<u>Committee Vote:</u> Favorable with amendments, 4-0 (In favor: Council Members Patterson, Turner, Davis and Taveras)

The Legislative Officer provided a summary of the bill and referral comments that were received. CB-59-2016 concerns the Landlord-Tenant Code Drug Activity and Prostitution for the purpose of making persons, Landlords, Landlords' agents, management staff and/or owners, as well as tenants, liable for the use of apartments for drug activities and/or for prostitution, including human trafficking. The bill provides for punishment for statutory violators, a voluntary program on human trafficking, voluntary registration, voluntary training, and voluntary certification, and generally regarding drug activity and/or prostitution, including human trafficking.

Representatives from the Prince Georges County Police Department and representatives from AOBA, the MBIA, and the Human Trafficking Task Force provided additional information and spoke in support of this legislation.

Amendments are as follows:

On page 1, after "violators;" insert "providing for certain inquiries;".

On page 1, in line 20, insert "and 13-162.00.04,"

On page 2, in line 16, strike "and" after "Section 13-162.00.03" insert "and Section 13-162.00.04"

On page 2, in line 9, strike "complicitly and/or"; and on page 2, in line 24, strike "complicitly and/or".

On page 2, strike "Sec. 13-162.00.03" and substitute "Sec.13-162.00.04". On page 2, after line 29, insert "Sec. 13-162.00.03 Inquiries, complaints.".

On page 2, after line 29, insert:

- (a) Any inquiries and/or complaints regarding prostitution and/or human trafficking to the Prince George's County 311 Call center shall be directed to the enforcing agencies of the County, including the Human Relations Commission.
- (b) The Human Relations Commission shall make available to property owners and landlords of rental properties requesting the information and/or the inquiries or complaints received regarding their rental properties.
- (c) The Human Relations Commission shall make available resources regarding prostitution and/or human trafficking to property owners and landlords of rental properties.

On page 3, in line 5, strike "<u>Department of Permitting, Inspections, and Enforcement</u>" and substitute "<u>Human Relations Commission</u>.".

On page 3, in line 4, strike "<u>shall</u>" and substitute "<u>may</u>". On page 3, in line 7, strike "<u>Department of Permitting, Inspection, and Enforcement</u>" and substitute "<u>Human Relations</u> Commission".
