A special exception shall not be required for an eating or drinking establishment with a gross floor area of at least 2,500 square feet in size, has a valid Dance Hall license issued before July 1, 2016, and has a valid Class BLX license issued by the Board of License Commissioners for Prince George's County pursuant to Title 26, Alcoholic Beverages Article, Annotated Code of Maryland, and shall be a permitted use, subject to conformance with the hours of operation established pursuant to the Class BLX license issued for the use.
