### **BACKGROUND INFORMATION/FISCAL IMPACT:**

Bakery products manufactuing is permitted in industrial zones, with the exception of the I-3 Zone. This bill amends the Industrial Use Table in the Zoning Ordinance to permit this use with other companion uses in the I-3 Zone under certain circumstances.
