(a) The Cour	ncil shall be the County Board of Health.				
(b) The Cour	ncil, sitting as the Board of Health, shall have all the powers and duties granted				
to a local Board	of Health under State law. It is the responsibility of the Board of Health, upon				
reasonable publi	c notice and consultation with the County Health Officer, to take any action				
pursuant to its au	thority, upon determining that it is in the public interest and consistent with				
Section 3-202 of	the Health General Article of the Annotated Code of Maryland, including but

1	not limited to the following:		
2	(1) Review, advise and make recommendations regarding policies related to health care		
3	facilities, health services, and public health in the County;		
4	(2) Review, advise and make recommendations regarding any development, enlargement		
5	or other modification of health care facilities that it determines are relevant to the County;		
6	(3) Review, advise and make recommendations regarding policies related to any County-		
7	funded or subsidized health clinics for the treatment and prevention of physical and mental		
8	illnesses;		
9	(4) Have general oversight for the health and sanitary interests of the people of the		
10	County including the investigation and study of the causes of disease, epidemics, nuisances		
11	affecting public health, prevention of contagious diseases and the preservation of health;		
12	(5) Promote and support policies and programs that encourage healthier lifestyles and		
13	better public health in the County, including educating the public with respect to environmental,		
14	physical and mental health;		
15	(6) Adopt regulations by Council resolution in furtherance of the responsibilities and		
16	objectives set forth in this Subsection; and		
17	(7) Enlist experts to assist in the execution of its duties.		
18	SECTION 2. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)		
19	calendar days after it becomes law.
