### **BACKGROUND INFORMATION/FISCAL IMPACT:**

An Adult Day Care Center is a defined use in Section 27-107.01 of the Zoning Ordinance, permitted by Special Exception in certain residential and commercial zones, and permitted by right in the Commercial Miscellaneous (C-M) Zone. This legislation amends the Comprehensive Design Zones Use Table to permit this use in the Employment and Institutional Area (E-I-A) Zone. A general principle for land uses in the E-I-A Zone is to provide concentrated nonretail employment or institutional (medical, religious, educational, recreational, and governmental) uses which serve the County, region, or a greater area.
