RESOLUTION

A RESOLUTION concerning

The Redevelopment Authority of Prince George's County Fiscal Year 2018 Operating Budget and Capital Improvement Program

For the purpose of approving the Capital Improvement Program of the Redevelopment Authority of Prince George's County for Fiscal Years 2018-2023; prepared pursuant to the authority contained in Subtitle 15B of the Prince George's County Code; and providing comments on the proposed Operating Budget of the Redevelopment Authority for Fiscal Year 2018.

WHEREAS, Section 15B-124 of the Prince George's County Code provides that the Redevelopment Authority of Prince George's County may propose one or more projects for inclusion in the Redevelopment Authority's Capital Improvement Program; and that the County Executive shall transmit to the County Council for its approval by resolution or ordinance any such project approved by the County Executive; and

WHEREAS, the County Executive has proposed for approval three Capital Projects for the Redevelopment Authority's Capital Improvement Program which consists of project numbers UM900995 County Revitalization, UM900053 Glenarden Apartments Redevelopment and UM900985 Suitland Manor, copies of which are attached hereto and incorporated herein by reference as though they were set forth fully herein, identified as Attachment 1; and

WHEREAS, Section 15B-123 of the Prince George's County Code provides that if the proposed operating budget of the Redevelopment Authority includes any item to be funded from payments to be received from the County that the anticipated receipts shall be identified for each item and a copy of the proposed budget shall be transmitted by the Redevelopment Authority to the County Executive and the County Council for their review and comment; and

WHEREAS, the Redevelopment Authority has forwarded its proposed operating budget to the County Executive and the County Council for review and comment as shown in the Appendix to the FY 2018 proposed budget, a copy of which is attached hereto and incorporated herein by reference as though it was set forth fully herein, identified as Attachment 2

SECTION 1. NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that subject to and in accordance with the authority of the Charter of Prince George's County and pursuant to Subtitle 15B of the Prince George's County Code, the Capital Improvement Program for Fiscal Years 2018-2023 of the Redevelopment Authority of Prince George's County, as submitted by the County Executive to the County Council, is hereby amended, authorized, approved and adopted as reflected in Attachment 1.

SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the proposed Fiscal Year 2018 Operating Budget of the Redevelopment Authority of Prince George's County and concurs with an Operating Budget of \$685,600 for the Redevelopment Authority, as reflected in Attachment 2.
