(k) Notwithstanding any other provision of this Division, the approval of Conceptual or Detailed Site Plans for development of property within the M-X-T Zone, including such requirements regarding density, setbacks, buffers, screening, landscaping, architecture, height restrictions, recreational requirements, ingress/egress, and/or internal circulation shall conform with the guidelines or standards set forth in any applicable Master Plan or Sector Plan approved for the area of the subject property.

SECTION 2. BE IT FURTHER ENACTED that this Ordinance shall not apply to the development of property within the M-X-T Zone for which a Conceptual or Detailed Site Plan application has been accepted as filed on the effective date of this Ordinance.
