Purpose of the Joint Workgroup

Purpose



- Identify opportunities for improvements to CB 74-2016 and Subtitle 10A (Procurement) of the Prince George's County Code
- Expand opportunities for County-based business to procurement County goods and services
- Ensure the efficient and timely procurement of goods and services by County agencies
- Identify ways to simplify the procurement code for vendors
- Reduce the administrative burdens on County employees



Benefits of CB 115-2017

CB 115-2017...



- Expands contracting opportunities for County-based businesses (10A-145(a), 10A-158.01(b), (10A-161(g)(1))
- Expands the annual County-based business set-aside program (10A-161(g)(1))
- Simplifies the procurement code for County vendors (Sections 10A-136, 10A-161(c), 10A-173(a))
- Streamlines the procurement process for improved continuity of services by County agencies and vendors (10A-108(a)(16), 10A-114(d), 10A-115(f) and (g))
- Simplifies the small purchase process (10A-115(d)(2), (f) and (g))
- Consolidates various reporting requirements (10A-136(r), 10A-138, 10A-155(e))
- Simplifies the preference point requirements (10A-136(c),(d) and (e), 10A-173(a))
- Clarifies and/or corrects confusing sections of the procurement code (10A-112(c)(2), 10A-136, 10A-115(d)(2), 10A-136(v))



Major Changes in CB 115-2017

Expands County-Based Business Opportunities



- Expands the annual County-based business set-aside process based upon a procurement forecast for CMBE and CBB (10A-161(g)(1))
- Increases the preference points for CMBE and CBSB to 15%, and CBB to 10% on bids or proposals not entirely made by CBB (10A-173(a))
 - > Decreases the preference points for CLB to 3% (10A-173(a))

Simplifies the Procurement Process for Vendors



- Consolidates preference terms into one section (10A-136, 10A-173(a))
- Simplifies the preference points calculation (10A-173(a))
- Identifies, in advance, future procurement opportunities for County-based businesses, which allows for County-based businesses to prepare for the solicitation (10A-161(g)(1))
- Creates a streamlined certification process for MDOT MBEcertified businesses, and other similarly certified-MBE businesses by other organizations (10A-163(g) and (i))

Streamlines the Procurement Process for County Agencies



- Eliminates the requirements for various determinations, and waiver approvals for micro-purchases (\$2,500 or less) (10A-108)(a)(16), 10A-115(g))
- Eliminates the time consuming waiver process for contracts that fall below the 40% CBSB requirements (10A-159.01)
 - > \$2,501 to \$500,000 Purchasing Agent approves waiver
 - > \$500,001 and above Chief Administrative Officer approves waiver with recommendation by Purchasing Agent
- Clarifies the "open market" definition to allow "direct relationship" purchases in order to ensure competitive pricing (10A-101(a)(28.1))
- Changes the \$5 million requirement for business development reserve program (BDRP) opportunities to an annual \$5 million goal in order to ensure competitive pricing (10A-158.01(b))
