BACKGROUND INFORMATION/FISCAL IMPACT:

This Resolution amends the Salary Plan for Sheriff Officials in the Office of the Sheriff with the following modifications: uniform wage scale modifications, merit payments, merit pop back language, FY 2018 cost of living adjustment, clothing allowance, group health insurance premiums, hold harmless provision and military leave.

A fiscal impact statement will be provided by the Office of Management and Budget.
