BACKGROUND INFORMATION/FISCAL IMPACT:

This bill amends the Dance Hall Licensing provisions set forth in Subtitle 5 of the County Code to provide a limited exemption to the licensing requirements for certain banquet halls and catering establishments that meet certain specific criteria.

9/19/2017 - CB-104-2017 was amended on the floor as follows: On page 2, in line 9, after "Zone", insert "or on property consisting of at least fifty (50) acres in the R-A (Residential Agricultural) Zone where the use was developed as part of a phased, planned development of a religious institution campus". CB-104-2017 (DR-2) was presented.
