Council Chair Glaros thanked staff for all their efforts during the holiday recess and provided a recap of the Council's Retreat entitled "Start Strong, Finish Stronger" held on January 3, 4, and 5 at The Hotel at the University of Maryland in College Park, Maryland. During the retreat the Coucil gathered with other elected and public officials, invited guests and staff to review presentations, discussed legislative priorities and goals and set out a course for the coming year. Among the topics discussed were the Zoning Ordinance Rewrite, Transportation, Transit Oriented and Economic Development, Tourism, Education Anchors, Fiscal Outlook, Board of Health Updates and the University of Maryland Capital Region Health.

The Council was prepared to meet in emergency session on December 28, 2017 in response to the new federal tax laws. This meeting was cancelled due to the Internal Revenue Service announcement.

Comments were also provided regarding the Family Crisis Center and the ongoing investigation into resident complaints. Best next steps will be determined once details from the inspections and results of the investgation are available.
