RESOLUTION

1 A RESOLUTION concerning

2 The Creation of a Food Truck Hub at Iverson Mall

3 For the purpose of authorizing the creation of a Food Truck Hub at Iverson Mall.

4 WHEREAS, Section 5-189.01 of the Prince George’s County Code generally requires that a
5 Food Truck Hub shall only be located on the open area or parking lot or public rights-of-way of
6 the following: parks and recreational facilities under the operation and control of the Maryland-
7 National Capital Park and Planning Commission, or areas within a one-quarter mile radius of the
8 station entrance of any Metro and MARC stations; and

9 WHEREAS, the Food Truck Hub located at 3737 Branch Avenue, Temple Hills, Maryland
10 20748 (See attached Exhibit), is neither located in the parks and recreational facilities under the
11 operation and control of the Maryland-National Capital Park and Planning Commission, nor
12 areas within a one-quarter mile radius of the station entrance of any Metro and MARC stations;
13 and

14 WHEREAS, Iverson Mall desires to create a Food Truck Hub in its location; and

15 WHEREAS, Section 5-189.01 authorizes that Food Truck Hubs not located at parks and
16 recreational facilities under the operation and control of the Maryland-National Capital Park and
17 Planning Commission or areas within a one-quarter mile radius of the station entrance of any
18 Metro and MARC stations may be granted special authorization by resolution of the County
19 Council; and

20 WHEREAS, the Iverson Food Truck Hub must still satisfy the requirements
21 for the Food Truck Hub License as enumerated in Section 5-189.03 of the County Code and
22 remain subject to approval by the Department of Permitting, Inspections, and Enforcement

1 pursuant to Section 5-189.01 of the County Code.

2 NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's
3 County, Maryland, that the County Council does hereby grant special authorization to the
4 Iverson Mall Food Truck Hub to become a Food Truck Hub.

5 BE IT FURTHER RESOLVED that such authorization by the County Council is subject to
6 Iverson Mall satisfying the requirements for the Food Truck Hub License as enumerated in
7 Section 5-189.03 of the County Code and subject to approval by the Department of Permitting,
8 Inspections, and Enforcement pursuant to Section 5-189.01 of the County Code.
