| WHEREAS, the Capital Budget for Fiscal Year 2019 equals Forty Three Million and Three | | | |
| Hundred Thousand dollars (\$35,391,000); and | | | |
| WHEREAS, Section 21A-118 of the Prince George's County Code provides that if the | | | |

proposed operating budget of the Authority includes any item to be funded from payments to be

received from the County that the anticipated receipts shall be identified for each item and a copy of the proposed budget shall be transmitted by the Authority to the County Executive and the County Council for their review and comment; and

WHEREAS, the Authority has forwarded its proposed operating budget to the County Executive and the County Council for review and comment, as shown in Attachment 2.

SECTION 1. BE IT THEREFORE RESOLVED by the County Council of Prince George's County, Maryland, that subject to and in accordance with the authority of the Charter of Prince George's County and pursuant to Subtitle 21A of the Prince George's County Code, the Capital Improvement Program for Fiscal Years 2019-2024 of the Revenue Authority of Prince George's County, as submitted by the County Executive to the County Council, a copy of which is attached hereto as Attachment 1 and incorporated herein by reference as though it was set forth fully herein, is hereby authorized, approved, and adopted.

SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the proposed Operating Budget, Fiscal Year 2019, of the Revenue Authority of Prince George's County and concurs with the proposed Operating Budget in the Revenue Authority as reflected in Attachment 2.
