BACKGROUND INFORMATION/FISCAL IMPACT:

The Redevelopment Authority is proposing a six-year Capital Improvement Program. This Resolution approves the proposed Fiscal Year 2019 Capital Budget in the amount of \$16,713,000 for four projects, as follows:

Addison Rd/Capitol Hts. Metro Corridor \$1,000,000

County Revitalization - \$1,000,000

Glenarden Apartments Redevelopment - \$10,713,000

Suitland Manor - \$4,000,000

The Redevelopment Authority is required to submit its proposed Operating Budget to the County Council for comments. This resolution states the Council's concurrence on the Authority's proposed FY 2019 Capital Budget of \$16,713,000, and an Operating Budget of approximately \$696,700.
