RESOLUTION

A RESOLUTION concerning

Contract Approvals

For the purpose of approving a multi-year Financing Agreement to fund essential Prince George's County equipment and vehicles.

WHEREAS, pursuant to Section 819 of the Prince George's County Charter, the County Council must approve, by resolution, all multi-year contracts exceeding an aggregate of Five Hundred Thousand Dollars (\$500,000.00); and

WHEREAS, pursuant to section 819 of the Prince George's County Charter, no agency of the County government shall during any fiscal year expend any money or incur any liability in excess of the amounts appropriated and no such payment shall be made nor any obligation or liability incurred, except for purchases in an amount to be fixed by legislative act; and

WHEREAS, the County desires to acquire through a tax-exempt lease purchase financing contract, or through the issuance of tax-exempt certificates of participation (the "COPs"), equipment and vehicles essential to the operations of County agencies and departments pursuant to the terms and conditions contained herein and made a part thereof, as Attachment A (the "Financing Agreement"); and

WHEREAS, the County has identified vehicles and equipment to purchase or lease purchase as identified and contained herein and made a pat thereof, as Attachment B (the "Equipment"); and

WHEREAS, the County desires to declare its official intent to reimburse itself for certain expenditures paid before receipt of the proceeds from the Financing Agreement (the "Advanced Expenditures") in accordance with applicable Treasury Regulations; and

NOW, THEREFORE, BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Financing Agreement as described in Attachment A and pursuant to Section 819 of the Prince George's County Charter be and the same is hereby APPROVED.

BE IT FURTHER RESOLVED that the County Council hereby declares the County's official intent to use the proceeds of the Financing Agreement to reimburse itself for the Advanced Expenditures. This section of the Resolution is adopted by the County Council for the purpose of establishing compliance with the requirements of Section 1.150-2 of Treasury Regulations. This section of the Resolution does not bind the County to make any expenditure, incur any indebtedness, or proceed with the purchase of the Equipment.

BE IT FURTHER RESOLVED that the County Executive is hereby authorized to make any modifications, adjustments, corrections or any other changes as may be necessary to finalize the contract in any manner the County Executive may deem necessary or proper but not altering its substance.
