CHARTER AMENDMENT

1 AN ACT concerning

2 Amendment of Section 308, Charter of Prince George's County

3 For the purpose of proposing an amendment to Section 308 of the Charter of Prince George's
4 County to provide that membership on the Council shall be considered a full-time position for
5 the purpose of determining compensation.

6 BY proposing an amendment to:

7 Section 308,

8 Charter of Prince George's County, Maryland.

9 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
10 Maryland, that the following amendment to Section 308, Charter of Prince George's County,
11 Maryland, is hereby proposed:

12 **Section 308. Compensation.**

13 The compensation of Council members may be changed by an affirmative vote of not less
14 than two-thirds of the members of the Council. Not later than December 15 of the last year of
15 each term, a compensation review board shall be appointed by the Council and the County
16 Executive to study the rate of current compensation for Council members and the County
17 Executive and make a recommendation regarding the amount of compensation. Membership on
18 the Council shall be considered a full-time position for the purpose of determining compensation.

19 The board shall issue its recommendation not later than the following February 15. The Council
20 may, within ninety days of the receipt of the compensation review board's recommendation,
21 amend the recommendation by a vote of not less than two-thirds of the full Council, otherwise

1 the recommendation shall stand approved. Any increase or decrease in compensation which
2 becomes law during one term of office shall not become effective before the next term.

3 SECTION 2. BE IT FURTHER ENACTED that a copy of this Act be transmitted to the
4 County Executive for publication and that a copy also be transmitted to the Board of Supervisors
5 of Elections for submission of the proposed amendment to the voters of this County at the 2018
6 General Election pursuant to Section 1105 of the Charter.

7 SECTION 3. BE IT FURTHER ENACTED that the question of adoption of this proposed
8 Charter Amendment shall be submitted to the voters of the County at the General Election
9 occurring on November 6, 2018, and shall be placed on the ballot in the following form:

11 PROPOSED CHARTER AMENDMENT

12 To provide that membership on the Council shall be considered a full-
13 time position for the purpose of determining compensation.

15 Adopted this 24th day of July , 2018, by an affirmative vote of two-thirds of the
16 members of the full County Council.
