## **BACKGROUND INFORMATION/FISCAL IMPACT:**

This bill will amend the prescriptions for development within certain specified D-D-O (Development District Overlay) Zones to incentivize development in the vicinity of transit stations in Prince George's County.

7/2/2018: Prior to introduction, a motion was made by Council Member Patterson, seconded by Council Member Franklin that Section 2 of CB-26-2018 (DR-2) be amended to allow for the bill to take effect upon the date of adoption. The motion carried 8-0. Council Member Harrison was absent. CB-26-2018 (DR-3) was introduced.
