BACKGROUND INFORMATION/FISCAL IMPACT:

The legislation is required to pursuant to Section 819 of the Prince George's County Charter. Section 819 requires personal service contracts exceeding an aggregate of One Hundred Thousand Dollars (\$100,000.00) per contractor or an aggregate of Five Hundred Thousand Dollars (\$500,000.00) for all other multiyear contracts must be approved by resolution of the County Council upon notice and public hearing.

This contract is to engage Johnson Controls Security Solutions, LLC (formerly Tyco Integrated Security, LLC) for facility security, equipment, systems and services for various Prince George's County agencies and facilities including but not limited to County Courthouse, Family Justice Center, County Administration Building, Chrysler Building and the Hyattsville Justice Center.
