## BACKGROUND INFORMATION/FISCAL IMPACT:

This bill will amend the Zoning Ordinance Residential Zones table of uses to permit certain mixed-use development in the R-18 and R-55 Zones of the County. The bill is needed to further implementation of the 2018 *East Riverdale - Beacon Heights Sector Plan* approved by the District Council on November 14, 2017, via adoption of CR-095-2018.
