## ATTACHMENT A

### AN ORDINANCE CONCERNING THE ZONING ORDINANCE OF PRINCE GEORGE'S COUNTY, MARYLAND

**PLEASE NOTE:**

While the Council enacted this legislation in October 2018, it shall not take effect unless and until a separate Countywide Sectional Map Amendment is approved by the Council in accordance with law.

Although not yet effective, the text of this bill may be revised and refined by further legislative action of the Council as provided by law. Pursuant to Council Rule 14.3, designated Legislative Branch staff "shall have authority to correct obvious errors in section references and number, references to existing law, capitalization, spelling, grammar, headings and similar matters".
