**RESOLUTION**

1 A RESOLUTION concerning

2 The Revenue Authority of Prince George's County Fiscal Year 2020

3 Operating Budget and Capital Improvement Program

4 For the purpose of approving the Capital Improvement Program of the Revenue Authority of  
5 Prince George's County for Fiscal Years 2020-2025, prepared pursuant to the authority contained  
6 in Subtitle 21A of the Prince George's County Code and providing comments on the proposed  
7 Operating Budget of the Authority for Fiscal Year 2020.

8 WHEREAS, Section 21A-119 of the Prince George's County Code provides that the  
9 Revenue Authority of Prince George's County may propose one or more projects for inclusion in  
10 the Authority's Capital Improvement Program and that the County Executive shall transmit to the  
11 County Council for its approval by resolution or ordinance any such project approved by the  
12 County Executive; and

13 WHEREAS, the Capital Improvement Program for the Revenue Authority includes three  
14 new parking garage projects and two renovation parking projects. The Hamilton Street Garage  
15 (WG900124), the New Carrollton Public Parking Garage (WG900123), the UM Capital Region  
16 Medical Center Garage (WG900200), the Suitland Project (WM900812), and the Hyattsville  
17 Justice Center Garage (WQ900822). Project descriptions are attached hereto as Attachment 1;  
18 and

19 WHEREAS, the Capital Budget for Fiscal Year 2020 equals Forty Million and Five  
20 Hundred Nine Thousand dollars (\$40,509,000); and

21 WHEREAS, Section 21A-118 of the Prince George's County Code provides that if the  
22 proposed operating budget of the Authority includes any item to be funded from payments to be

1 received from the County that the anticipated receipts shall be identified for each item and a copy  
2 of the proposed budget shall be transmitted by the Authority to the County Executive and the  
3 County Council for their review and comment; and

4 WHEREAS, the Authority has forwarded its proposed operating budget to the County  
5 Executive and the County Council for review and comment, as shown in Attachment 2.

6 SECTION 1. BE IT THEREFORE RESOLVED by the County Council of Prince George’s  
7 County, Maryland, that subject to and in accordance with the authority of the Charter of Prince  
8 George’s County and pursuant to Subtitle 21A of the Prince George’s County Code, the Capital  
9 Improvement Program for Fiscal Years 2020-2025 of the Revenue Authority of Prince George’s  
10 County, as submitted by the County Executive to the County Council, a copy of which is  
11 attached hereto as Attachment 1 and incorporated herein by reference as though it was set forth  
12 fully herein, is hereby authorized, approved, and adopted.

13 SECTION 2. BE IT FURTHER RESOLVED that the County Council has reviewed the  
14 proposed Fiscal Year 2020 Operating Budget of the Revenue Authority of Prince George’s  
15 County and concurs with the proposed Operating Budget for the Revenue Authority as reflected  
16 in Attachment 2.
