## **BACKGROUND INFORMATION/FISCAL IMPACT:**

Additionally, this Resolution will amend the FY 2019 Annual Action Plan by reprogramming and reallocating one million, five hundred thousand dollars (\$1,500,000) in HOME Investment Partnerships ("HOME") Program funds from the FY 2017, FY 2018 and FY 2019 Annual Action Plans to support the project.
