BILL

1 AN ACT concerning

2 The Issuance and Sale of General Obligation and
3 Stormwater Management Bonds

4 For the purpose of authorizing and empowering Prince George's County, Maryland to issue and
5 sell an amount not to exceed Four Hundred Fifty-Five Million, Five Hundred Twenty-Three
6 Thousand (\$455,523,000) in aggregate principal amount of general obligation and stormwater
7 management bonds for the purpose of providing funds for financing in whole or in part costs of
8 the planning, acquisition, construction, reconstruction, establishment, extension, enlargement,
9 demolition, or improvement of certain capital projects and capital projects constituting facilities
10 (including without limitation any land, interest in land or equipment) for the control and
11 disposition of storm and surface waters, including floodproofing, flood control or navigation
12 programs and other stormwater programs and systems, environmental restoration and/or
13 wetlands construction, and the protection, conservation, creation and acquisition of certain
14 property described in the Maryland Annotated Code Environment Article consistent with federal
15 and Maryland laws and regulations on the subject of nontidal and private wetlands, as
16 applicable, including describing the capital projects to be financed in whole or in part from the
17 proceeds of the bonds hereby authorized and the estimated costs thereof; or purchase of certain
18 capital projects set forth in the capital budget of the County for the fiscal year ending June 30,
19 2020, or usable portions thereof, including describing the capital projects to be financed in whole
20 or in part from the proceeds of the bonds hereby authorized and the estimated costs and the
21 probable useful lives thereof; prescribing or providing for the procedures for the issuance and

1 sale of such bonds at private (negotiated) sale or public sale public sale; declaring the County's
2 official intent to reimburse itself for certain expenditures paid before the issuance of the bonds
3 authorized hereby in accordance with applicable Income Tax Regulations; authorizing the
4 consolidation of such bonds with other bonds for purposes of such sale; showing compliance
5 with the power of the County to incur indebtedness; directing the application of the proceeds of
6 such bonds and the proceeds of bonds previously issued by an act of the County; pledging the
7 full faith and credit and taxing power of the County to the payment of such bonds and providing
8 for the levy and collection of taxes necessary for the payment of the principal of and interest on
9 such bonds when due and covenanting to issue the bonds in anticipation of which such notes are
10 issued; authorizing the pledge of Clean Water Act Fees to the payment of the principal of and
11 interest on such bond anticipation notes when due; authorizing and empowering the County to
12 issue and sell an amount not to exceed Four Hundred Fifty-Five Million, Five Hundred Twenty-
13 Three Thousand (\$455,523,000); directing the application of the proceeds of such bonds;
14 providing for the issuance of such bond anticipation notes in the form of commercial paper or
15 revolving loan notes; providing for the issuance of such bond anticipation notes and the bonds
16 authorized hereby in the form of variable rate demand obligations; authorizing certain
17 determinations to be made in connection with the sale of any such bond anticipation notes;
18 authorizing the consolidation of such bond anticipation notes with other notes for purposes of
19 such sale; authorizing and empowering the County to issue, sell and deliver general obligation
20 and stormwater management refunding bonds for the purpose of refunding all or a part of the
21 bonds authorized hereby or in prior Acts of the County in an aggregate principal amount not to
22 exceed 150% of the outstanding principal amount of the bonds to be refunded thereby, the
23 proceeds of such refunding bonds to be used for the public purpose of providing funds sufficient
24 to pay principal of, redemption premium, if any, and interest on such refunded bonds at the
25 respective maturity, redemption, and interest payment dates of such refunded bonds; prescribing
26 or providing for the procedure for the issuance and sale of such refunding bonds; empowering
27 the County Executive to determine the time and method for the sale of such refunding bonds and
28 other details with respect to the sale of such refunding bonds; pledging the full faith and credit of
29 the County to the payment of such refunding bonds and the interest on such refunding bonds,
30 when due; and providing for the levy and collection of taxes necessary for the payment of the
31 principal of and interest on such refunding bonds when due, showing compliance with the

1 limitations on the power of the County to incur indebtedness; authorizing the pledge of Clean
 2 Water Act Fees to the payment of the principal of and interest on such refunding bonds related to
 3 clean water projects when due; covenanting or providing for the making of certain covenants on
 4 matters relating to the tax-exempt status of interest on such bonds, bond anticipation notes and
 5 refunding bonds, as applicable; providing for compliance with Securities and Exchange
 6 Commission Rule 15c2-12; providing for the authorization of and entry into interest rate
 7 exchange agreements or contracts in connection with or incidental to any of the obligations
 8 authorized by this Act; authorizing the County Executive to delegate to appropriate officials the
 9 power to make certain determinations and sign certain documents, certificates or agreements
 10 authorized to be made or signed by the County Executive herein; and otherwise generally
 11 determining or providing for the determination of certain matters in connection with the
 12 issuance, sale and delivery of the general obligation and stormwater management bonds, bond
 13 anticipation notes and refunding bonds authorized by this Act.

14 SECTION 1. BE IT ENACTED by the County Council of Prince George's County,
 15 Maryland, that the issuance, sale and delivery of general obligation and stormwater management
 16 bonds with serial maturities, including mandatory sinking fund installments in lieu of serial
 17 maturities (the "Bonds") of Prince George's County, Maryland (the "County"), in one or more
 18 series from time to time in an aggregate principal amount not exceeding Four Hundred Fifty-
 19 Five Million, Five Hundred Twenty-Three Thousand (\$455,523,000) is hereby authorized,
 20 pursuant to Md. Local Government Code Ann. §10-203 and § 21-601 et seq., and Maryland
 21 Annotated Code Environment Article respectively as amended, replaced or recodified from time
 22 to time, in order to finance in whole or part costs of the planning, acquisition, construction,
 23 reconstruction, establishment, extension, enlargement, improvement, demolition or purchase of
 24 capital projects (the "Authorized Capital Projects") listed in the table set forth in Attachment 1,
 25 attached to and made a part of this Act (the "Table of Projects") . Each Authorized Capital
 26 Project is described in the Capital Budget of the County for the fiscal year ending June 30, 2020
 27 (the "Capital Budget") under the heading set forth in the Table of Projects and has the
 28 identification number set forth in the Table of Projects. The descriptions of the Authorized
 29 Capital Projects contained in the Capital Budget are incorporated herein by reference as if set
 30 forth fully herein. The principal amount of Bonds authorized by this Act to finance costs of each
 31 Authorized Capital Project shall be the respective amount set forth in the columns in the Table of

1 Projects marked "Authorized Principal Amount of Bonds." Each such principal amount of
2 Bonds is hereby determined to be sufficient to complete at least a usable portion of the
3 Authorized Capital Project in respect of which such principal amount has been authorized. The
4 probable useful lives of the Authorized Capital Projects are set forth in the Table of Projects. The
5 Bonds shall be made payable within the average of the probable useful lives of the Authorized
6 Capital Projects, which is _____ years, or, in the event the Bonds are consolidated with
7 other bonds of the County pursuant to Section 3 of this Act, within the average of the probable
8 useful lives of the capital projects financed with the proceeds of such consolidated issue of bonds
9 (the "Consolidated Authorized Capital Projects"). All Authorized Capital Projects have been
10 identified and included in bond enabling acts ("Bond Enabling Acts") and have been approved
11 by referendum to the extent required by applicable law. The Bonds are specifically exempted
12 from the provisions of Md. Local Government Code Ann. §§ 19-205 and 19-206, as amended,
13 replaced or recodified from time to time. The powers granted under this Act are additional and
14 cumulative and the Bonds authorized by this Act may be issued, notwithstanding that other bond
15 acts or laws may provide for the same or similar purposes. This Act authorizes the refunding of
16 general obligation bonds including stormwater management bonds authorized by prior acts, but
17 does not further modify or repeal any prior acts granting bond issuing authority for the same or
18 similar purposes. In the event that the County determines to exercise such refunding option for
19 the purpose of effecting certain cost savings by refinancing a portion of the indebtedness
20 evidenced by the such prior bonds through the issuance and sale of refunding bonds, it is the
21 intent of the County that such refunding bonds be issued under the Enabling Acts referred to in
22 such prior acts and that such refunding bonds, if issued, shall constitute a refunding of
23 indebtedness authorized by this Act and to the extent so authorized by prior acts, and shall not
24 constitute additional indebtedness under such authority or under any other authority.

25
26 SECTION 2. BE IT FURTHER ENACTED that the attached Table of Projects lists the
27 Authorized Capital Projects that are to be financed in whole or in part with the proceeds of the
28 Bonds, the currently estimated cost of each Authorized Capital Project or a usable portion
29 thereof (the "Estimated Cost"), the portion of the Estimated Cost of each Authorized Capital
30 Project to be financed hereunder (the "Bond Financed Portion"), the source or sources of funds
31 to finance the balance of the Estimated Cost of each Authorized Capital Project (the "Other

1 Funding Sources") and the probable useful life of each Authorized Capital Project.

2 It is hereby recognized and acknowledged that the information regarding the Estimated
3 Cost, Bond Financed Portion and Other Funding Source for each Authorized Capital Project set
4 forth in the Table of Projects is derived from information and estimates referenced in the Capital
5 Budget and the Capital Improvement Program of the County for fiscal years 2020 through 2025,
6 inclusive (the "Capital Improvement Program"), and is necessarily subject to change because of
7 corresponding changes in construction and other costs, project time schedules, availability of
8 Other Funding Sources and other circumstances not now known or anticipated. It is the purpose
9 and intent of this Act to authorize the borrowing of money to finance the Authorized Capital
10 Projects as such projects are referenced in the Capital Budget and Capital Improvement Program
11 and in any amended or subsequent capital budget or capital improvement program. To
12 implement the intent and purpose of this Act in the most expeditious manner, the County
13 Executive of the County (the "County Executive") may (i) add to the Table of Projects any
14 project contained in the Capital Improvement Program or in any amended or subsequent capital
15 budget or capital improvement program, provided that such project is a project that may be
16 financed by bonds issued pursuant to this Act; (ii) delete any Authorized Capital Project from the
17 Table of Projects; and (iii) revise the amounts set forth in the Table of Projects representing the
18 Estimated Cost, Bond Financed Portion and Other Funding Sources for any Authorized Capital
19 Project to be consistent with the information set forth in regard to such project in any amended
20 or subsequent capital budget or capital improvement program. In the event that the Bond
21 Financed Portion for an Authorized Capital Project is less than the amount appropriated for such
22 project in the Capital Budget or any amended or subsequent capital budget and the entire
23 principal amount of bonds issued for the Authorized Capital Projects is not required for such
24 projects, the County Executive may revise the Table of Projects to increase the Bond Financed
25 Portion of such Authorized Capital Project to an amount not to exceed the appropriated amount
26 for such project and, correspondingly, may reduce the Bond Financed Portion of such other
27 Authorized Capital Projects and make other appropriate adjustments. Nothing contained in this
28 Act shall be deemed to preclude the County Council by resolution from effecting such a revision
29 in the Table of Projects. The authority granted in this Act to revise the Table of Projects shall not
30 be construed to permit an increase in the aggregate principal amount of Bonds to be issued
31 pursuant to this Act or to effect results inconsistent with applicable laws. The County expects

1 that certain costs of the Authorized Capital Projects will be paid before the date of issuance of
 2 the Bonds (or other obligations of the County to be issued after the date of adoption of this Act)
 3 from a source of funds other than a County borrowing (each, a "Prior Expenditure" and
 4 collectively, the "Prior Expenditures"). The County hereby declares, in accordance with Section
 5 1.150-2 of the Income Tax Regulations, its intention to use a portion of the proceeds of the
 6 Bonds (or other obligations of the County to be issued after the date of adoption of this Act) to
 7 reimburse itself for Prior Expenditures paid no earlier than 60 days before the date of adoption of
 8 this Act. In accordance with Section 1.150-2 of the Income Tax Regulations, the maximum
 9 principal amount of obligations expected to be issued for the Authorized Capital Projects is set
 10 forth in the Table of Projects. The County recognizes that, under Section 1.150-2 of the Income
 11 Tax Regulations, the use of proceeds of the Bonds to reimburse the County for a Prior
 12 Expenditure (other than certain de minimis or preliminary expenditures described in Section
 13 1.150-2(f) of the Income Tax Regulations) generally will be permitted only to the extent that: (i)
 14 the Prior Expenditure constitutes a capital expenditure for federal income tax purposes; (ii) the
 15 Prior Expenditure was paid not earlier than 60 days before the date of adoption of this Act; and
 16 (iii) the allocation of proceeds of the Bonds to such reimbursement is made not later than 18
 17 months after the later of (a) the date the Prior Expenditure was paid, or (b) the date the
 18 applicable Authorized Capital Project is placed in service or abandoned, but in no event more
 19 than three years after the Prior Expenditure was paid.

20 SECTION 3. BE IT FURTHER ENACTED that as determined by the County Executive,
 21 the Bonds (or any portion of them, as applicable) may be issued, sold and delivered as a single
 22 series of Bonds or as two or more series of Bonds, or may be consolidated for issuance, sale and
 23 delivery with other bonds of the County (including bonds sold for new money and/or refunding
 24 purposes) as contemplated by Md. Local Government Code Ann. § 19-101, as amended,
 25 replaced or recodified from time to time. The Bonds of each series issued solely as general
 26 obligation bonds pursuant to the authority of this Act shall each be designated "Prince George's
 27 County, Maryland General Obligation Public Improvement Bonds, Series 20__," and the Bonds
 28 of each series consolidated for issuance with other such bonds of the County as authorized by
 29 this Section 3 shall each be designated "Prince George's County, Maryland General Obligation
 30 Consolidated Public Improvement Bonds, Series 20__", and the bonds issued as stormwater
 31 management bonds solely pursuant to the authority of this Act shall each be designated "Prince

1 George's County, Maryland Stormwater Management Bonds, Series 20__," and the Bonds of
2 each series consolidated for issuance with other such bonds of the County as authorized by this
3 Section 3 shall each be designated "Prince George's County, Maryland Consolidated Stormwater
4 Management Bonds, Series 20__," and, in the event any such Bonds are issued at more than one
5 time, the County Executive may specify such additional designation as he shall deem
6 appropriate. Moreover, the County Executive is hereby authorized to provide such other or
7 alternative designation as he deems necessary or convenient.

8 Upon consolidation of any of stormwater management bonds with general obligation
9 bonds issued pursuant to Md. Local Government Code Ann. §10-203, as amended, and
10 determination of the County Executive, there shall be pledged to the payment of said Bonds the
11 full faith and credit of the County and the power of the County to levy ad valorem taxes upon all
12 the legally assessable property within the corporate limits of the County (in addition to the
13 pledge and levy of taxes within the Stormwater Management District (hereinafter defined) and
14 the pledge of Clean Water Act Fees (hereinafter defined) effected pursuant to Section 10 hereof).

15 SECTION 4. BE IT FURTHER ENACTED that, subject to and in accordance with the
16 provisions of this Act, the County Executive shall determine all matters relating to the sale,
17 issuance, delivery and payment of the Bonds, including all matters relating to the forms, dates
18 and denominations of the Bonds, the dates and amounts of principal maturities, whether all or
19 any portion of the Bonds shall be term bonds subject to mandatory sinking fund redemption and
20 the dates and amounts of any such redemptions, the methods to be used in determining interest
21 payable on the Bonds and the dates on which such interest is payable, the provision of bond
22 insurance on all or any portion of the Bonds, and provisions for registration of the Bonds, for
23 their redemption prior to stated maturity, and for the use of facsimile signatures or seals, whether
24 the Bonds are to be issued in book-entry form and all matters incident to the issuance of the
25 Bonds in book-entry form. The County Executive shall provide for the form, numbering, term
26 and authentication of the Bonds pursuant to Section 822 of the County Charter and the form and
27 manner of execution and delivery of all documents necessary or deemed appropriate in
28 connection with the authorization, issuance, execution, sale, delivery and payment of and for the
29 Bonds. The County Executive may provide that no Bonds shall be issued for certain Authorized
30 Capital Projects authorized by this Act to be financed by the Bonds and reduce the aggregate
31 principal amount of Bonds to be issued accordingly, provided, however that the deletion of such

1 Authorized Capital Projects shall not cause the Bonds to be payable beyond the average of the
2 probable useful lives of the remaining Authorized Capital Projects. The County Executive may
3 provide for a reduction in the aggregate principal amount of Bonds to be issued consistent with a
4 determination of the minimum bond denomination size based on municipal security market
5 practices regarding denomination size, and for a corresponding reduction in the principal amount
6 of Bonds issued to finance the cost of any Authorized Capital Project. It is hereby recognized
7 and acknowledged that, in order to manage prudently the capital programs of the County,
8 particularly in light of federal income tax laws and regulations that impose penalties and other
9 financial consequences for the failure to expend the proceeds of tax-exempt bonds in a timely
10 manner, the County Executive, pursuant to Section 3 of this Act, may provide for the financing
11 of the Bond Financed Portion of an Authorized Capital Project by the issuance of Bonds at more
12 than one time and from time to time. Notwithstanding the provisions of Sections 2, 3 and 4 of
13 this Act, no order of the County Executive permitted under this Act shall authorize or permit a
14 reduction in the principal amount of Bonds issued for an Authorized Capital Project below the
15 amount for which the County Council has authorized temporary borrowing from other County
16 funds.

17 The County Executive may provide for certain maturities of the Bonds to be subject to prior
18 redemption at the option of the County. If the County Executive so provides and the Bonds are
19 issued with such option, then in the event that the County determines to exercise such option for
20 the purpose of effecting certain cost savings by refinancing a portion of the indebtedness
21 evidenced by the Bonds through the issuance and sale of refunding bonds, it is the intent of the
22 County that such refunding bonds be issued under the Enabling Acts referred to in this Act and
23 that such refunding bonds, if issued, shall constitute a refunding of indebtedness authorized by
24 this Act and shall not constitute additional indebtedness under such authority or under any other
25 authority. The aggregate principal amount of Bonds authorized to be issued hereunder may be
26 increased by a supplemental ordinance.

27 SECTION 5. BE IT FURTHER ENACTED that the Bonds issued as general obligation
28 bonds shall be sold at public sale at, above or below par value, plus, if so determined by the
29 County Executive, accrued interest to the date of delivery, by electronic bids and/or written
30 sealed proposals to the bidder or bidders therefor for cash whose bid or bids are determined to be
31 in the best interest of the County, as provided in the Notice of Sale for the Bonds, after having

1 given public notice of sale by electronic dissemination and/or advertisement as provided herein.
2 Unless contrary to applicable law, the Notice of Sale may be disseminated solely by electronic
3 means provided that bidders may submit electronic bids to purchase the Bonds, and any such
4 electronic dissemination of the Notice of Sale to be available to potential bidders seven (7) days
5 or more prior to the date of sale or such shorter period of time as is then customary for electronic
6 dissemination of notices of sale of municipal obligations in the nature of the Bonds.

7 Alternatively, or additionally, the Notice of Sale, or a summary thereof, may be published once
8 in each of two consecutive weeks next preceding the date of sale of the Bonds in the County
9 newspapers of record, and, in the event any single newspaper of record meets the circulation
10 requirements of Section 1008 of the County Charter, as amended, modified or recodified from
11 time to time, such publication may be made solely in such single newspaper of record. The first
12 of such publications shall be ten (10) or more days preceding the date of sale of the Bonds. Such
13 Notice of Sale, or a summary thereof, may also be published in "The Bond Buyer", a financial
14 journal published in the City of New York and/or in such other publications as the Director of
15 Finance may determine to be in the best interest of the County. The Bonds offered for sale at
16 such public sale shall be awarded by the County Executive. Authority is hereby expressly
17 delegated to the County Executive to fix the date and the time of the sale of the Bonds. The sale
18 of the Bonds shall be held in a County Executive Conference Room in the County
19 Administration Building in Upper Marlboro, Maryland, or in such other place as may be
20 designated in accordance with the Notice of Sale for the Bonds.

21 The County Executive shall determine whether the Bonds issued as stormwater
22 management bonds shall be sold at public sale by electronic bids and/or written sealed proposals
23 or by private (negotiated) sale and the procedures to be followed in connection with any such
24 sale. Authority is hereby expressly delegated to the County Executive to (i) fix the date and the
25 time of the sale of such Bonds; (ii) determine the form and terms of any Notice of Sale; (iii) to
26 determine whether any Notice of Sale shall be disseminated in electronic form and/or whether
27 such Notice of Sale or a summary thereof shall be published in connection with any public sale
28 of such Bonds; and (iv) to award such Bonds at public sale or to approve the form and terms of,
29 and authorize the execution and delivery by and on behalf of the County of, a bond purchase
30 agreement with underwriters purchasing such Bonds in any private (negotiated) sale. Such
31 Bonds may be sold at, above or below the par value thereof.

1 SECTION 6. BE IT FURTHER ENACTED that there may be printed on each of the Bonds
2 the text of the approving legal opinion of bond counsel or co-bond counsel with respect to such
3 Bonds. Any such printed text shall be certified to be a correct copy of said opinion by the manual
4 or facsimile signature of the County Executive.

5 The Bonds shall contain similar provisions and be in substantially the form set forth in
6 Attachment 2, attached hereto and made a part hereof, and Bonds issued substantially in
7 accordance with said form, with appropriate insertions as indicated, when properly executed and
8 authenticated as required by this Section 6 shall be deemed to constitute unconditional general
9 obligations of the County, to the payment of which, in accordance with the terms thereof, its full
10 faith and credit are pledged, and all the covenants and conditions contained in the Bonds shall be
11 deemed to be binding upon the County.

12 Authority is hereby conferred on the County Executive to complete, delete or modify the
13 blanks in such bond form with necessary information, to insert applicable paragraphs as
14 indicated or needed and to make such additions, deletions and substitutions in such bond form,
15 not inconsistent with this Act or the County Charter, as may be necessary or desirable for the
16 sale of the Bonds, including (without limitation) such additions, deletions and substitutions as
17 may be necessary or desirable in connection with the establishment or discontinuance of a book-
18 entry registration system for the Bonds and such changes as may be necessary to reserve to the
19 County the option to call for mandatory tender for purchase of all or any portion of the Bonds.

20 SECTION 7. BE IT FURTHER ENACTED that immediately after the sale of the Bonds,
21 the interest rate or rates payable on the Bonds shall be fixed by an order of the County Executive
22 (the authority to fix such rates being hereby expressly delegated to said County Executive) in
23 accordance with the respective terms and conditions of the sale of the Bonds.

24 SECTION 8. BE IT FURTHER ENACTED that if the Bonds are sold by public sale the
25 official Notice of Sale and Bid for the Bonds shall be substantially in the form set forth in
26 Attachment 3 attached hereto and made a part hereof, with such insertions or deletions as the
27 County Executive may determine to be desirable to allow for the use of electronic bidding or due
28 to financial or market conditions or as otherwise permitted or required by this Act, including but
29 not limited to changes appropriate in the event that the Bonds are to be registered in book-entry
30 format.

31 SECTION 9. BE IT FURTHER ENACTED that the County Executive may authorize on

1 | behalf of the County the preparation and distribution of a preliminary official statement and a
2 | final official statement or similar offering documents in connection with the issuance and sale of
3 | the Bonds.

5 | SECTION 10. BE IT FURTHER ENACTED that the proceeds of the sale of the Bonds,
6 | including any premium and accrued interest received therefor, shall be paid directly to the
7 | Director of Finance of the County, who shall deposit the same in the proper accounts of the
8 | County. The costs of issuance of the Bonds shall be allocated to the Authorized Capital Projects
9 | financed by the Bonds and shall be charged to the appropriate debt service accounts of the
10 | County by the Director of Finance. There shall be deducted from the total gross proceeds
11 | received for the Bonds any amount received on account of accrued interest and premium on such
12 | Bonds, which amounts shall be set apart by the Director of Finance in separate accounts and
13 | applied to the first interest payment on the Bonds; provided that, if so determined by the County
14 | Executive, any premium on such Bonds may be applied to other purposes, including (without
15 | limitation) payment of the costs of issuance. The balance of the proceeds of the sale of the Bonds
16 | shall be expended by the County for costs of the Authorized Capital Projects for which Bonds
17 | have been issued in accordance with this Act. If the principal amount of Bonds issued for any
18 | Authorized Capital Project exceeds the amount needed to finance such Authorized Capital
19 | Project, the excess shall be applied to any other Authorized Capital Project or if no such
20 | Authorized Capital Project requires additional funds, to any other capital project permitted by the
21 | laws of the State of Maryland and of the County.

22 | Unless otherwise provided by act or resolution of the County Council or by the County
23 | Executive pursuant to Section 11 of this Act, earnings derived from the investment of the
24 | proceeds of the Bonds may be treated as general revenues of the County and applied to general
25 | County purposes and such use of investment proceeds is hereby acknowledged and authorized.

26 | SECTION 11. BE IT FURTHER ENACTED that the County Executive is hereby
27 | authorized to determine the amount of bonds issued for capital projects and stormwater
28 | management bonds issued for stormwater projects permitted by the laws of the State of
29 | Maryland and of the County and the County Charter, including without limitation Md. Local
30 | Government Code Ann. § 21-601 et seq., any excess of the amount needed to finance such
31 | authorized capital and stormwater management projects may be used to (i) finance an

1 Authorized Capital Project as defined in this Act or an capital project or stormwater project
2 defined as an authorized project in a previous act of the County Council, (ii) the refunding of the
3 Bonds or (iii) debt service on the Bonds.

4 The County Executive may transfer appropriations between capital projects equal to the
5 amount determined to be in excess of the amount not needed to finance the Authorized Capital
6 Projects as defined in this Act or a capital project or stormwater management project defined as
7 an authorized capital project in a previous act of the County Council.

8 SECTION 12. BE IT FURTHER ENACTED that, for the purpose of paying the interest on
9 and redeeming and paying the portion of the Bonds issued for stormwater management projects
10 , as they respectively mature or become subject to mandatory redemption, the County shall
11 include in the levy in each and every fiscal year during which any of the such bonds are
12 outstanding a direct ad valorem tax upon all property assessed for tax purposes within the
13 stormwater management district established by the County pursuant to Md. Local Government
14 Code Ann. § 21-601 et seq., (the "Stormwater Management District") (except as otherwise
15 provided therein) at a rate required to produce the amount needed to pay, in addition to the other
16 costs of stormwater management to be paid from amounts in the Stormwater Management
17 District Fund (defined herein) pursuant to Md. Local Government Code Ann. § 21-601 et seq.,
18 for the interest on such bonds payable during such fiscal year and the principal of all of the
19 Bonds maturing or becoming subject to mandatory sinking fund redemption in each such fiscal
20 year, and in the event the proceeds from taxes so levied in any such fiscal year shall prove
21 insufficient for such purposes, additional taxes, unlimited as to rate or amount, shall be levied
22 within the Stormwater Management District in succeeding fiscal years to make up such
23 deficiency, all as authorized and provided for in Md. Local Government Code Ann. § 21-601 et
24 seq. The County may apply to the payment of the principal of and interest on the Bonds any
25 funds received by it from the State of Maryland, the United States of America, or any agency or
26 instrumentality thereof, or from any other source, if such funds are granted for the purpose of
27 assisting the County in obtaining public facilities of the class or classes of public facilities for
28 which such bonds, or the respective portions of such bonds, are authorized or may be otherwise
29 lawfully applied to such payment; to the extent that any such funds are applied to such purposes
30 in any fiscal year as provided herein, the taxes hereby required to be levied shall be reduced
31 proportionately.

1 The full faith and credit of the County and the unlimited taxing power of the County are
2 hereby irrevocably pledged both to the punctual payment of the maturing principal of and
3 interest on the Bonds as and when such principal and interest respectively become due, and to
4 the levy and collection of the taxes hereinabove prescribed as and when such taxes become
5 necessary in order to provide sufficient funds to meet the debt service requirements of the Bonds.
6 The County hereby solemnly covenants with each of the registered owners of any of the Bonds
7 to take all action as may be appropriate from time to time during the period that any of the Bonds
8 remain outstanding and unpaid to provide the funds necessary to make the principal and interest
9 payments on the Bonds.

10 The debt service requirements of the Bonds issued for stormwater management projects
11 shall have a first and prior claim on all moneys of the Stormwater Management District Fund of
12 the County established pursuant to Md. Local Government Code Ann. § 21-601 et seq. (the
13 "Stormwater Management District Fund"), on a parity with the claim for moneys required for
14 payment of debt service on all other County general obligation stormwater management bonds
15 issued pursuant to the authority contained in Md. Local Government Code Ann. § 21-601 et seq.,
16 whether issued prior to or after the issuance of such Bonds, and the other purposes for which
17 funds in the Stormwater Management District Fund may be disbursed pursuant to Md. Local
18 Government Code Ann. § 21-601 et seq. The County further covenants and agrees with each of
19 the registered owners of any of the Bonds issued for stormwater management projects to levy
20 and collect the taxes hereinabove prescribed.

21 In addition, there is hereby pledged to the payment of the interest on and redeeming and
22 paying the Bonds issued for stormwater management projects, as they respectively mature or
23 become subject to mandatory redemption, the Clean Water Act Fees collected by the County (the
24 "Clean Water Act Fees") in accordance with Title 4 of the Environment Article of the Annotated
25 Code of Maryland and Section 10-301 et seq. of the Prince George's County Code, each as
26 amended, replaced or recodified from time to time (collectively, the "Stormwater Acts") and
27 deposited in the Local Watershed Protection and Restoration Fund. The debt service
28 requirements of such Bonds shall have a first and prior claim on all Clean Water Act Fees on
29 deposit in the Local Watershed Protection and Restoration Fund on a parity with the claim for
30 moneys required for payment of debt service on all other County bonds to which such Clean
31 Water Act Fees shall be pledged, and the other purposes for which funds in the Local Watershed

1 Protection and Restoration Fund may be disbursed pursuant to the Stormwater Acts.

2 SECTION 13. BE IT FURTHER ENACTED that the County Council hereby determines
3 that the Bonds are at present within the debt limit imposed by Md. Local Government Code Ann.
4 § 10-203, as amended, replaced or recodified from time to time (the "Express Powers Act"). The
5 County is authorized under the Express Powers Act to undertake borrowings for any public
6 purposes of the County, provided that the aggregate amount of bonds or other evidences of
7 indebtedness therefor outstanding at any one time shall not exceed a total of six percent (6%) of
8 the County's assessable basis of real property and fifteen percent (15%) of the County's
9 assessable basis of personal property and operating real property described in Section 8-109(c)
10 of the Tax-Property Article of the Annotated Code of Maryland, as amended, replaced or
11 recodified from time to time, as shown below:

4 SECTION 14. BE IT FURTHER ENACTED that the County Executive may transfer
5 appropriations between capital projects equal to the amount determined to be in excess of the
6 amount not needed to finance the Authorized Capital Projects as defined in this Act or a capital
7 project defined as an authorized capital project in a previous act of the County Council.

8 SECTION 15. BE IT FURTHER ENACTED that, for the purpose of paying the interest on
9 and redeeming and paying the Bonds, as they respectively mature or become subject to
10 mandatory redemption, the County shall include in the levy in each and every fiscal year during
11 which any of the Bonds are outstanding ad valorem taxes upon all the legally assessable property
12 within the corporate limits of the County in rate and amount sufficient to provide for the
13 payment, when due, of the interest on the Bonds payable during such fiscal year and the
14 principal of all of the Bonds due in each such fiscal year; and in the event the proceeds from
15 taxes so levied in any such fiscal year shall prove inadequate for such purposes, additional taxes
16 shall be levied, to the extent authorized by law, in succeeding fiscal years to make up such
17 deficiency. The County may apply to the payment of the principal of and interest on the Bonds
18 any funds received by it from the State of Maryland, the United States of America, or any
19 agency or instrumentality thereof, or from any other source, if such funds are granted for the
20 purpose of assisting the County in obtaining public facilities of the class or classes of public
21 facilities for which the Bonds, or the respective portions of the Bonds, are authorized or may be
22 otherwise lawfully applied to such payment; to the extent that any such funds are applied to such
23 purposes in any fiscal year as provided herein, the taxes hereby required to be levied shall be
24 reduced proportionately.

25 The full faith and credit of the County and the taxing power of the County are hereby irrevocably
26 pledged both to the punctual payment of the maturing principal of and interest on the Bonds as
27 and when such principal and interest respectively become due, and to the levy and collection of
28 the taxes hereinabove prescribed as and when such taxes become necessary in order to provide
29 sufficient funds to meet the debt service requirements of the Bonds. The County hereby
30 solemnly covenants with each of the registered owners of any of the Bonds to take all action as
31 may be appropriate from time to time during the period that any of the Bonds remain outstanding

1 and unpaid to provide the funds necessary to make the principal and interest payments on the
2 Bonds. The debt service requirements of the Bonds shall have a first and prior claim on all
3 moneys of the General Fund of the County on a parity with the claim for moneys required for
4 payment of debt service on all other County general obligation indebtedness whether issued prior
5 to or after the issuance of the Bonds; it is recognized, however, that some outstanding general
6 obligation bonds of the County constitute a pledge of the unlimited taxing power of the County.
7 The County further covenants and agrees with each of the registered owners of any of the Bonds
8 to levy and collect the taxes hereinabove prescribed.

9 SECTION 16. BE IT FURTHER ENACTED that in the event any official of the County
10 whose signature shall appear on any Bonds or on other instruments or documents pertaining
11 thereto, shall cease to be such official prior to the delivery of the Bonds or other instruments or
12 documents, or in the event that any official shall take office subsequent to the sale of the Bonds,
13 his or her signature shall nevertheless be valid, sufficient and binding for the purposes herein
14 intended.

15 SECTION 17. BE IT FURTHER ENACTED that the County Executive shall be the officer
16 of the County responsible for the issuance of any Bonds within the meaning of the "arbitrage
17 regulations" (defined below).

18 In the event that Bonds are issued pursuant to this Act with the expectation that interest on
19 such Bonds will be excludable from gross income for federal income tax purposes, the County
20 Executive shall be the officer of the County responsible for the execution and delivery (on the
21 date of issuance of the Bonds) of a certificate of the County (the "Tax and Section 148
22 Certificate") which complies with the requirements of Section 148 of the Internal Revenue Code
23 of 1986, as amended ("Section 148"), and the applicable regulations thereunder (the "arbitrage
24 regulations"), and such official is hereby directed to execute the Tax and Section 148 Certificate
25 and to deliver the same to bond counsel or co-bond counsel on the date of the issuance of the
26 Bonds.

27 The County shall set forth in the Tax and Section 148 Certificate its reasonable
28 expectations as to relevant facts, estimates and circumstances relating to the use of the proceeds
29 of the Bonds, or of any moneys, securities or other obligations on deposit to the credit of any
30 account of the County which may be deemed to be proceeds of the Bonds pursuant to Section
31 148 or the arbitrage regulations (collectively, "Bond Proceeds"). The County covenants that the

1 facts, estimates and circumstances set forth in the Tax and Section 148 Certificate will be based
2 on the County's reasonable expectations on the date of issuance of the Bonds and will be, to the
3 best of the certifying official's knowledge, true and correct, as of that date. The County shall also
4 set forth in the Tax and Section 148 Certificate any elections provided for or permitted under the
5 provisions of the Internal Revenue Code of 1986, as amended, that the official executing the Tax
6 and Section 148 Certificate deems advisable.

7 In the event that Bonds are issued pursuant to this Act with the expectation that interest on
8 such Bonds will be excludable from gross income for federal income tax purposes, the County
9 covenants with each of the registered owners of any of the Bonds that it will not make, or (to the
10 extent that it exercises control or direction) permit to be made, any use of the Bond Proceeds
11 which would cause the Bonds to be "arbitrage bonds" within the meaning of Section 148 and the
12 arbitrage regulations. The County further solemnly covenants that it will comply with Section
13 148 and the regulations thereunder which are applicable to the Bonds on the date of issuance
14 thereof and which may subsequently lawfully be made applicable thereto as long as the Bonds
15 remain outstanding and unpaid. The County Executive is hereby authorized and directed to
16 prepare or cause to be prepared and to approve and execute, respectively, any certification,
17 opinion or other document, including, without limitation, the Tax and Section 148 Certificate
18 which may be required to assure that the Bonds will not be deemed to be "arbitrage bonds"
19 within the meaning of Section 148 and the regulations thereunder.

20 In the event that Bonds are issued pursuant to this Act with the expectation that interest on
21 such Bonds will be excludable from gross income for federal income tax purposes, the County
22 Executive may make such covenants or agreements in connection with the issuance of such
23 Bonds as he or she shall deem advisable in order to assure the registered owners of such Bonds
24 that interest thereon shall be and remain excludable from gross income for federal income tax
25 purposes, and such covenants or agreements shall be binding on the County so long as the
26 observance by the County of any such covenants or agreements is necessary in connection with
27 the maintenance of the exclusion of the interest on such Bonds from gross income for federal
28 income tax purposes. The foregoing covenants and agreements may include such covenants or
29 agreements on behalf of the County regarding compliance with the provisions of the Internal
30 Revenue Code of 1986, as amended, as the County Executive shall deem advisable in order to
31 assure the registered owners of such Bonds that the interest thereon shall be and remain

1 | excludable from gross income for federal income tax purposes, including (without limitation)
2 | covenants or agreements relating to the investment of Bond Proceeds, the payment of certain
3 | earnings resulting from such investment to the United States (or certain payments in lieu thereof
4 | as provided in the Internal Revenue Code of 1986, as amended), limitations on the times within
5 | which, and the purpose for which, Bond Proceeds may be expended, or the use of specified
6 | procedures for accounting for and segregating Bond Proceeds. Any covenant or agreement made
7 | pursuant to this paragraph may be set forth in the Tax and Section 148 Certificate.

8 | SECTION 18. BE IT FURTHER ENACTED that the County Executive is hereby
9 | authorized to select and appoint a bank or other financial institution to act as paying agent for the
10 | payment of the principal and redemption price, if any, of and interest on the Bonds and to act as
11 | registrar for the Bonds. The selection of the paying agent and bond registrar shall be
12 | accomplished in accordance with applicable provisions of law. In the event that the Bonds are
13 | issued in book-entry form, the County Executive may determine that a bond registrar and paying
14 | agent need not be designated or that the County shall act as bond registrar and paying agent.

15 | SECTION 19. BE IT FURTHER ENACTED that the powers granted by this Act are
16 | additional and cumulative and the Bonds authorized by this Act may be issued, notwithstanding
17 | that other bond acts or laws may provide for the issuance of other bonds or the borrowing of
18 | money for the same or similar purposes on the same or other terms and conditions. This Act shall
19 | be liberally construed to effectuate its purposes, namely, to authorize the borrowing of money
20 | and the incurring of indebtedness to finance the Authorized Capital Projects set forth in this Act.
21 | Provisions of this Act shall be deemed met and satisfied if there is substantial compliance with
22 | such provisions. This Act is not intended to provide or imply that this Act or any prior act not
23 | containing a similar provision precludes the County from exercising any power or prerogative
24 | provided by this Act or any other law whether exercised solely pursuant to such other law or in
25 | conjunction with the powers provided by this Act so that, without limiting the generality of this
26 | Section, the County may exercise the power to issue (i) bond anticipation notes (in anticipation
27 | of the issuance of bonds pursuant to this Act or otherwise) and grant anticipation notes pursuant
28 | to Md. Local Government Code Ann. § 19-211 et seq., as amended, replaced, or recodified from
29 | time to time, (ii) bonds (or any related bond anticipation or other notes) authorized by Md.
30 | Economic Development Code Ann. § 12-201 et seq. as amended, replaced, or recodified from
31 | time to time, and (iii) loan obligations authorized by Title 9, Subtitle 16 of the Environment

1 Article of the Annotated Code of Maryland, as amended, replaced, or recodified from time to
2 time, and in exercising such powers, the County may sell such notes, bonds or loan obligations at
3 private (negotiated) sale as authorized by these or any other applicable laws.

4 SECTION 20. BE IT FURTHER ENACTED that in order to avoid the issuance of a greater
5 amount of Bonds for the Authorized Capital Projects listed in the Table of Projects than is
6 needed therefor, and in order to permit the construction of such projects to proceed prior to the
7 issuance of Bonds and at the same time afford the County maximum flexibility in selecting the
8 most advantageous times for such issuance, the County may provide needed capital funds by the
9 issue and sale of its bond anticipation notes (the "Notes") pursuant to the authority of Md. Local
10 Government Code Ann. § 19-211, as amended, replaced or recodified from time to time (the
11 "Bond Anticipation Note Act").

12 (1) The maximum principal amount of such Notes issued pursuant to this Section which
13 may be outstanding at any time shall be Four Hundred Fifty-Five Million, Five Hundred
14 Twenty-Three Thousand (\$455,523,000) unless and until otherwise provided by the County
15 Council by act. The proceeds of the sale of the Notes, after any payment from such proceeds of
16 the expenses of issuance of the Notes, shall be expended only on the public purposes or any
17 applicable portion thereof for which the Bonds are authorized. Twelve months' interest on any
18 issue of Notes, or any renewal thereof, may be paid from the proceeds, or from the proceeds of
19 the sale of the Bonds, accounting from the initial date of issue thereof, as determined by the
20 County Executive. The Notes may be paid at or prior to maturity from the proceeds of the
21 issuance and sale of the Bonds in anticipation of which the Notes were issued or from the
22 proceeds of refunding Notes. Except as otherwise provided herein, in the event of such an
23 advance refunding, the proceeds of such refunding Bonds or Notes shall be held in escrow, to the
24 extent and in the amount necessary to refund the outstanding series of Notes, for the benefit of
25 the holders of the outstanding series of Notes. Such refunding Notes, if issued, will constitute a
26 reissuance of the Notes authorized by this Act and shall not constitute additional indebtedness
27 under such authorization.

28 (2) All or any part of the Notes may be issued in series as funds are required, as determined
29 by the County Executive.

30 (3) The Notes may be sold at, above or below the par value thereof, including Commercial
31 Paper Notes (hereinafter defined) as hereinafter provided; none of such Notes shall bear interest

1 at a rate in excess of the maximum interest rate, if any, specified by the County Council by
2 public local law to be payable on obligations of Prince George's County, Maryland.

3 (4) With respect to any Notes issued, the County hereby covenants and agrees with the
4 holder or holders thereof to issue, upon its full faith and credit, the Bonds in anticipation of the
5 sale of which the Notes are issued when, and as soon as, the reason for deferring the issuance
6 thereof no longer exists and to pay the principal of and interest on (to the extent such interest has
7 not been capitalized, or otherwise paid, by appropriations from current revenues) such Notes
8 from the proceeds of such Bonds. This covenant shall be binding upon the County
9 notwithstanding any limitation set forth in this Act, including (without limitation) any limitation
10 with respect to the interest rate or rates that the Bonds may bear. If the County shall be unable,
11 for reasons beyond its control, to issue and sell its Bonds as described above, or if the proceeds
12 from the sale of such Bonds shall be insufficient to pay the principal of and interest on any Notes
13 issued, then the revenues from taxes and other sources intended for application to debt service on
14 such Bonds shall be applied to the payment of the interest on and principal of the Notes. The
15 foregoing provisions shall not be construed so as to prohibit the County from paying the
16 principal or redemption price of and interest on any Note issued hereunder from the proceeds of
17 the sale of any other Note issued hereunder, or from any other funds legally available for that
18 purpose.

19 If the County shall be unable, for reasons beyond its control, to issue and sell its Bonds, or
20 if the proceeds from the sale of such Bonds shall be insufficient to pay the principal of or interest
21 on any Notes issued, then the County shall include in the levy in each and every fiscal year
22 during which any of the Notes are outstanding ad valorem taxes upon all the legally assessable
23 property within the corporate limits of the County in rate and amount sufficient to provide for
24 payment, when due, of the interest on the Notes payable during such fiscal year and the principal
25 of all of the Notes due in each such fiscal year, and during which any Notes for stormwater
26 management projects are outstanding a direct ad valorem tax upon all property assessed for tax
27 purposes within the Stormwater Management District (except as otherwise provided in Md.
28 Local Government Code Ann. § 21-601 et seq.) at a rate required to produce the amount needed
29 to pay, in addition to the other costs of stormwater management to be paid from amounts in the
30 Stormwater Management District Fund pursuant to Md. Local Government Code Ann. § 21-601
31 et seq., for the interest on the Notes for stormwater management projects payable during such

1 fiscal year and the principal of all of such Notes maturing or becoming subject to mandatory
2 sinking fund redemption in each such fiscal year; and in the event the proceeds from taxes so
3 levied in any such fiscal year shall prove insufficient for such purposes, additional taxes,
4 unlimited as to rate and amount, shall be levied within the Stormwater Management District in
5 succeeding fiscal years to make up such deficiency, all as authorized and provided for in Md.
6 Local Government Code Ann. § 21-8 601 et seq. The County may apply to the payment of the
7 principal of and interest on the Notes any funds received by it from the State of Maryland, the
8 United States of America, or any agency or instrumentality thereof, or from any other source, if
9 such funds are granted for the purposes of assisting the County in obtaining public facilities of
10 the class or classes of public facilities for which the Notes, or the respective portions of the
11 Notes, are authorized or may be otherwise lawfully applied to such payment; to the extent that
12 any such funds are applied to such purposes in any fiscal year as provided herein, the taxes
13 hereby required to be levied shall be reduced proportionately.

14 The full faith and credit of the County and the unlimited taxing power of the County are
15 hereby irrevocably pledged both to the punctual payment of the maturing principal of and
16 interest on the Notes as and when such principal and interest respectively become due, and to the
17 levy and collection of the taxes hereinabove prescribed as and when such taxes become
18 necessary in order to provide sufficient funds to meet the debt service requirements of the Notes.
19 The County hereby solemnly covenants with each of the owners of any of the Notes to take all
20 action as may be appropriate from time to time during the period that any of the Notes remain
21 outstanding and unpaid to provide the funds necessary to make the principal and interest
22 payments on the Notes. The debt service requirements of the Notes for stormwater management
23 projects shall have a first and prior claim on all moneys of the Stormwater Management District
24 Fund on a parity with the claim for moneys required for payment of debt service on all other
25 County general obligation stormwater management indebtedness issued pursuant to the authority
26 contained in Md. Local Government Code Ann. § 21-601 et seq., whether issued prior to or after
27 the issuance of the Notes, and the other purposes for which funds in the Stormwater
28 Management District Fund may be disbursed pursuant to Md. Local Government Code Ann. §
29 21-601 et seq. The County further covenants and agrees with each of the owners of any of the
30 Notes to levy and collect the taxes hereinabove prescribed.

31 In addition, there is hereby pledged to the payment of the interest on and redeeming and

1 paying the Notes for stormwater management projects, as they respectively mature or become
2 subject to mandatory redemption, the Clean Water Act Fees collected by the County in
3 accordance with the Stormwater Acts and deposited in the Local Watershed Protection and
4 Restoration Fund. The debt service requirements of such Notes shall have a first and prior claim
5 on all Clean Water Act Fees on deposit in the Local Watershed Protection and Restoration Fund
6 on a parity with the claim for moneys required for payment of debt service on all other County
7 general obligation stormwater management indebtedness to which such Clean Water Act Fees
8 shall be pledged, and the other purposes for which funds in the Local Watershed Protection and
9 Restoration Fund may be disbursed pursuant to the Stormwater Acts.

10 (5) In the event that any Notes (the "Outstanding Notes") issued hereunder are outstanding
11 on the date that the Bonds in anticipation of which such Notes are issued are delivered in
12 exchange for the purchase price thereof (the "Delivery Date"), the Director of Finance shall
13 deposit with the paying agent for the Notes, or a trustee or escrow agent, on the Delivery Date (i)
14 cash in an amount equal to the principal of the Outstanding Notes and/or (ii) direct obligations
15 of, or obligations the payment of which is unconditionally guaranteed by, the United States of
16 America, the principal of and interest on which will be sufficient without reinvestment to pay in
17 a timely manner the principal of the Outstanding Notes when due whether at maturity or upon
18 prior redemption. Such paying agent or trustee or escrow agent is hereby irrevocably directed to
19 apply such cash or the proceeds of such obligations to the payment of the principal of the
20 Outstanding Notes when due whether at maturity or upon prior redemption. The County may
21 provide such cash or obligations from the proceeds of the sale of such Bonds or from any other
22 funds legally available for such purpose. On the Delivery Date, the Director of Finance shall also
23 deposit with the paying agent for the Outstanding Notes, or a trustee or escrow agent (i) cash in
24 an amount equal to the interest on the Outstanding Notes when due and/or (ii) direct obligations
25 of, or obligations the payment of which is unconditionally guaranteed by, the United States of
26 America, the principal of and interest on which will be sufficient without reinvestment to pay in
27 a timely manner interest on the Outstanding Notes when due, whether at maturity, upon a
28 regularly scheduled payment date or upon prior redemption. The County may provide such cash
29 obligations from the proceeds of the sale of Bonds available for that purpose or from any other
30 funds legally available for such purpose. Notwithstanding the foregoing, if the Delivery Date and
31 the date on which the Outstanding Notes mature or are subject to redemption are in different

1 fiscal years, and moneys for the payment of the interest on the Outstanding Notes have not been
 2 finally appropriated in the fiscal year in which the Bonds are delivered, and if the Delivery Date
 3 is after the date on which the budget for the succeeding fiscal year has been submitted to the
 4 County Council and provision for the payment of the interest on such Outstanding Notes has
 5 been made in such budget, in lieu of the deposit of such cash or obligations for the payment of
 6 interest on the Outstanding Notes, the County Executive, the Director of Finance and/or the
 7 Chief Administrative Officer may deliver a certificate on the Delivery Date of the Bonds stating
 8 that funds sufficient to pay the interest on the Outstanding Notes have been included in the
 9 budget for the next succeeding fiscal year (it being provided by the Bond Anticipation Note Act
 10 that the Notes shall be payable from the first proceeds of the sale of the Bonds, or from the tax or
 11 other revenue which the County shall have previously determined to apply to the payment of the
 12 Bonds and the interest thereon). Upon the deposit with the paying agent for the Outstanding
 13 Notes, or a trustee or escrow agent, of cash and/or obligations sufficient to provide for the
 14 payment of the principal of and interest on such Notes when due, as described above, such Notes
 15 shall be deemed to be paid and no longer outstanding hereunder.

16 (6) With respect to the authorization, issuance, execution, sale, delivery and payment of and
 17 for any Notes, the County Executive may determine, approve, authorize or provide for:

- 18 (i) the identification of any series of Notes;
- 19 (ii) the form of any Notes;
- 20 (iii) the denominations of the Notes;
- 21 (iv) the maturity of any Notes;
- 22 (v) the manner of execution and authentication of any Notes;
- 23 (vi) the rate or rates of interest of any Notes or the manner for determining the same;
- 24 (vii) the interest payment dates of any Notes;
- 25 (viii) the redemption provisions applicable to any Notes;
- 26 (ix) the manner of sale of any Notes, which may be by private (negotiated) sale
 27 or at public sale, and the procedures to be followed in connection with any such sale;
- 28 (x) the form and manner of execution and delivery of documents necessary or deemed
 29 appropriate in connection with the authorization, issuance, execution, sale, delivery and payment
 30 of and for any Notes; and
- 31 (xi) such other matters not inconsistent with the provisions of this Act as are necessary

1 or deemed appropriate to accomplishing the issuance and sale of Notes hereunder, including
2 other matters specifically authorized by the Bond Anticipation Note Act.

3 (7) As determined by the County Executive, the Notes (or any portion of them, as
4 applicable) may be issued, sold and delivered as a single series of Notes or as two or more series
5 of Notes, or may be consolidated for issuance, sale and delivery with other notes of the County
6 (including notes sold for new money and/or refunding purposes) as contemplated by Md. Local
7 Government Code Ann. § 19-101, as amended, replaced or recodified from time to time.

8 (8) References to "Bonds" in Section 12 of this Act shall be deemed to include Notes.

9 (9) The authority conferred on the County Executive in Section 13 of this Act in connection
10 with the issuance of Bonds hereunder, with respect to the appointment of paying agents and a
11 registrar, may also be exercised with respect to the issuance and sale of Notes hereunder.

12 (10) References to "Bonds authorized by this Act" in Section 14 of this Act shall be deemed
13 to include Notes, unless the context clearly requires otherwise.

14 (11) Pursuant to the Bond Anticipation Note Act, the County is hereby authorized to issue
15 the aforementioned Notes as notes in the nature of commercial paper and to establish a
16 commercial paper program. Accordingly, the County is hereby authorized to issue two or more
17 separate and distinct series of its Notes, which may include (1) a series of its Notes in the nature
18 of tax-exempt commercial paper (the "Commercial Paper Notes") and (2) a series of its Notes in
19 connection with a liquidity facility, such as a revolving loan agreement, or a series of its Notes in
20 connection with a credit facility, such as a letter of credit and related agreements (collectively,
21 the "Revolving Loan Notes") (the Commercial Paper Notes and the Revolving Loan Notes being
22 collectively referred to herein as the "Program Notes"). The word "Notes," as used in this Act,
23 includes Program Notes, and it is intended that the provisions of this Act applying to Notes shall
24 include Program Notes unless the context clearly requires a contrary meaning. For the purposes
25 of this Act, the term "principal amount," when used with respect to the Program Notes, shall
26 mean (i) in the case of Commercial Paper Notes, the face amount of any such Commercial Paper
27 Note, less any original issue discount on such Commercial Paper Note, and (ii) in the case of
28 Revolving Loan Notes, the principal amount actually advanced under the applicable liquidity
29 facility or credit facility that is evidenced by any such Revolving Loan Note. Accordingly, it is
30 contemplated by this Act that the aggregate face amount of the Program Notes that may be
31 outstanding from time to time hereunder, together with other Notes issued hereunder and

1 outstanding from time to time, may exceed the aggregate principal amount of Notes authorized
2 to be outstanding hereunder at any one time.

3 Without limiting the generality of other provisions of this Act, the County Executive may
4 determine, approve, authorize or provide for:

5 (i) procedures to facilitate the prompt determination and approval of matters in
6 connection with the authorization, issuance, execution, sale, delivery and payment of and for
7 Program Notes;

8 (ii) the form and manner of execution and delivery of documents necessary or deemed
9 appropriate in connection with the authorization, issuance, execution, sale, delivery and payment
10 of and for Program Notes;

11 (iii) the selection of any trustee, issuing agent, payment agent, commercial paper
12 dealer, credit or liquidity facility provider or other provider of financial or related services
13 necessary or deemed appropriate to the authorization, issuance, execution, sale, delivery and
14 payment of and for Program Notes; and

15 (iv) such other matters not inconsistent with this Act necessary or deemed appropriate
16 to accomplishing the authorization, issuance, execution, sale, delivery and payment of and for
17 Program Notes.

18 SECTION 21. BE IT FURTHER ENACTED that it is hereby found and determined as
19 follows: (i) it is in the best interest of the County to be able to implement a flexible approach to
20 borrowing (that is, one which provides the ability to utilize variable rate demand obligations, tax-
21 exempt commercial paper and short-term municipal obligations [collectively, "Variable Rate
22 Demand Obligations"]); (ii) there is an expanding market for Variable Rate Demand Obligations,
23 which have varying and flexible maturities or redemption features, tender or purchase dates and
24 bear interest at variable rates established by a remarketing agent on the basis of current market
25 conditions, or combinations of such maturities or redemption, tender or purchase dates and rates
26 and to access this market the County must establish procedures consistent with market practices
27 for Variable Rate Demand Obligations; and (iii) existing practices in the market for Variable
28 Rate Demand Obligations and existing requirements of nationally recognized rating agencies
29 require that there be available to the issuer of Variable Rate Demand Obligations a supporting
30 credit or liquidity facility, such as a letter of credit, line of credit or revolving loan agreement,
31 pursuant to which an alternate source of borrowing will be available during any period in which

1 such obligations cannot be remarketed or sold.

2 Notes or Bonds are hereby authorized to be issued as short-term or demand obligations or
 3 commercial paper, defined above as Variable Rate Demand Obligations, including obligations
 4 that are required to be purchased or redeemed prior to stated maturity dates, bear interest at
 5 variable rates and mature on dates established from time to time by a remarketing agent on the
 6 basis of current market conditions. If any Bonds or Notes issued in accordance with this Section
 7 provide for the optional or mandatory redemption, tender or purchase thereof prior to stated
 8 maturity dates, the form of Bond or Note (as the case may be) may provide, to the extent
 9 permitted by law and determined by the County Executive that the full faith and credit and
 10 unlimited taxing power of the County are pledged to the payment of the purchase or redemption
 11 price on the due dates for such payments.

12 Without limiting the generality of other provisions of this Act, the County Executive may
 13 determine, approve, authorize or provide for:

14 (i) procedures for the determination of the interest rates, the interest payment dates, the
 15 maturities and any optional or mandatory redemption, tender or purchase dates of Bonds or
 16 Notes described in this Section in order to implement the financing authorized hereby;

17 (ii) the form and manner of execution and delivery of documents necessary or deemed
 18 appropriate in connection with the authorization, issuance, execution, sale, delivery and payment
 19 of and for Variable Rate Demand Obligations;

20 (iii) the selection of any trustee, issuing agent, paying agent, tender agent, credit or
 21 liquidity facility provider or other provider of financial or related services necessary or deemed
 22 appropriate to the authorization, issuance, execution, sale, delivery and payment of and for
 23 Variable Rate Demand Obligations; and

24 (iv) such other matters not inconsistent with this Act necessary or deemed appropriate
 25 to accomplishing the authorization, issuance, execution, sale, delivery and payment of and for
 26 Variable Rate Demand Obligations.

27 SECTION 22. BE IT FURTHER ENACTED that Md. Local Government Code Ann. § 19-
 28 207, as amended, replaced or recodified from time to time (the "Refunding Act"), provides that
 29 refunding bonds may be issued by the County for certain public purposes specified in the
 30 Refunding Act, including realizing savings to the County in the aggregate cost of debt service on
 31 either a direct comparison or present value basis or debt restructuring that in the aggregate

1 effects such a reduction in the cost of debt service. The County Council of Prince George's
2 County, Maryland, hereby finds and determines that the issuance of refunding bonds pursuant to
3 the terms and requirements of this Act in order to refund all or a portion of the outstanding
4 principal amount of the Bonds will effectuate and accomplish the public purpose of realizing
5 savings to the County in the aggregate cost of debt service on either a direct comparison or a
6 present value basis or of debt restructuring that in the aggregate effects such a reduction in the
7 cost of debt service.

8 SECTION 23. BE IT FURTHER ENACTED that, acting pursuant to the authority of the
9 Refunding Act , the County Charter, this Act and certain other authority pursuant to which the
10 Bonds will be issued, the issuance and sale of bonds (the "Refunding Bonds") of Prince George's
11 County, Maryland, which may be issued in one or more series from time to time as hereinafter
12 provided, are hereby authorized in an aggregate principal amount not to exceed 150% of the
13 aggregate outstanding principal amount of the Bonds to be refunded thereby (the "Refunded
14 Bonds") in order to provide funds sufficient (a) to purchase direct obligations of, or obligations
15 the timely payment of the principal of and interest on which is unconditionally guaranteed by,
16 the United States of America ("Government Obligations"), the principal of and interest on which
17 will be sufficient without reinvestment, together with any available cash, to pay in a timely
18 manner all or any part of the principal of and redemption premium, if any, and interest on the
19 Refunded Bonds, and (b) to pay any and all other costs permitted to be paid from the proceeds of
20 such Refunding Bonds under the Refunding Act, including (without limitation) funded interest,
21 the costs of issuance of such Refunding Bonds (including without limitation any bond insurance
22 premium payable by the County) and applicable underwriting fees.

23 SECTION 24. BE IT FURTHER ENACTED that the Refunding Bonds hereby authorized
24 may be sold for a price at, above, or below par, plus, if so determined by the County Executive,
25 accrued interest to the date of delivery. The Refunding Bonds shall be sold at private
26 (negotiated) sale, and such procedure is hereby determined to be in the public interest due to the
27 ability to negotiate flexible terms and achieve a beneficial interest rate or rates and the flexibility
28 to time the date of sale to maximum savings or achieve other public purposes permitted by the
29 Refunding Act. Notwithstanding the foregoing, if the County Executive subsequently determines
30 that it is in the best interests of the County to sell any or all of the Refunding Bonds after first
31 soliciting competitive bids at public sale, then the County Executive may provide for the sale of

1 such Refunding Bonds in such manner and in accordance with such procedures as he or she shall
2 deem appropriate; provided, however, that such procedures shall be substantially similar to the
3 procedures for public sale with competitive bidding normally used by the County in connection
4 with the sale of its general obligation bonds. Refunding Bonds issued hereunder are hereby
5 specifically exempted from the provisions of Md. Local Government Code Ann. §§ 19-204, 19-
6 205 and 19-206, as amended, replaced or recodified.

7 SECTION 25. BE IT FURTHER ENACTED that as determined by the County Executive,
8 the Refunding Bonds (or any portion of them, as applicable) may be issued, sold and delivered as
9 a single series of Refunding Bonds or as two or more series of Refunding Bonds, or may be
10 consolidated for issuance, sale and delivery with other bonds of the County (including bonds
11 sold for new money and/or refunding purposes) as contemplated by Md. Local Government
12 Code Ann. § 19-101 and 19-103, as amended, replaced or recodified from time to time. The
13 Refunding Bonds of each series issued solely pursuant to the authority of this Act shall each be
14 designated "Prince George's County, Maryland General Obligation Public Improvement
15 Refunding Bonds, Series 20__," and the Refunding Bonds of each series consolidated for
16 issuance with other bonds of the County as authorized herein shall each be designated "Prince
17 George's County, Maryland General Obligation Consolidated Public Improvement Refunding
18 Bonds, Series 20__", and the Refunding Bonds with regard to stormwater management projects
19 of each series sold solely pursuant to the authority of this Act shall each be designated "Prince
20 George's County, Maryland Stormwater Management Refunding Bonds, Series __ 20 ," and such
21 Refunding Bonds of each series consolidated for issuance with other bonds of the County as
22 authorized herein shall each be designated "Prince George's County, Maryland Consolidated
23 Stormwater Management Refunding Bonds, Series 20__", and, in the event any Refunding
24 Bonds are issued at more than one time, the County Executive may specify such additional
25 designation as he or she shall deem appropriate Moreover, the County Executive is hereby
26 authorized to provide such other or alternative designation as he or she deems necessary or
27 convenient.

28 Upon consolidation of any of the Refunding Bonds with general obligation bonds issued
29 pursuant to Md. Local Government Code Ann. § 10-203, as amended, and determination of the
30 County Executive, there shall be pledged to the payment of said Refunding Bonds the full faith
31 and credit of the County and the power of the County to levy ad valorem taxes upon all the

1 | legally assessable property within the corporate limits of the County (in addition to the pledge
2 | and levy of taxes within the Stormwater Management District and the pledge of Clean Water Act
3 | Fees for Refunding Bonds with regard to stormwater management projects).

4 | SECTION 26. BE IT FURTHER ENACTED that pursuant to this Act, the County
5 | Executive shall determine (a) the principal amounts and maturities of each series of Refunding
6 | Bonds to be issued and (b) the portions of each series of Refunded Bonds to be refunded with the
7 | proceeds of each series of Refunding Bonds; provided, however, that the issuance of any series
8 | of Refunding Bonds to refund all or any portion of one or more series of Refunded Bonds will
9 | effectuate and accomplish the public purpose of realizing savings to the County in the aggregate
10 | cost of debt service on either a direct comparison or a present value basis with respect to the
11 | portion of any series of Refunded Bonds being refunded or debt restructuring that in the
12 | aggregate effects such a reduction in the cost of debt service.

13 | There may be printed on the reverse side of each series of Refunding Bonds issued
14 | hereunder the text of the applicable approving legal opinion with respect thereto, and any such
15 | text shall be duly certified by the manual or facsimile signature of the County Executive of the
16 | County.

17 | Each series of Refunding Bonds shall be in the form set forth in Attachment 2 attached to
18 | and made a part of this Act with such changes in designation and purpose to reflect that such
19 | Refunding Bonds are refunding bonds, and Refunding Bonds issued substantially in compliance
20 | with such form, with appropriate insertions as therein indicated, when properly executed and
21 | authenticated as described above, shall be deemed to constitute unconditional general obligations
22 | of the County, to the payment of which, in accordance with the terms thereof, its full faith and
23 | credit are pledged, and all the covenants and conditions contained in such Refunding Bonds shall
24 | be deemed to be binding upon the County in accordance therewith. Authority is hereby conferred
25 | on the County Executive to fill the blanks in such form with the required information, to insert
26 | applicable paragraphs as indicated and to make such additions, deletions and substitutions in
27 | such form, not inconsistent with this Act or the Refunding Act, as may be necessary or desirable
28 | in the sale of any such series of Refunding Bonds, including (without limitation) such changes as
29 | may be necessary to permit the establishment of a central depository or book-entry system with
30 | respect to such series of Refunding Bonds.

31 | SECTION 27. BE IT FURTHER ENACTED that, for the purpose of paying the interest

1 and redeeming and paying the Refunding Bonds, as they respectively mature or become subject
2 to mandatory redemption, the County shall include in the levy in each and every fiscal year
3 during which any of the Refunding Bonds are outstanding a direct ad valorem tax upon all
4 legally assessable property assessed for tax purposes within the corporate limits of the County
5 and with respect to Refunding Bonds with regard to stormwater management projects,
6 Stormwater Management District (except as otherwise provided pursuant to Md. Local
7 Government Code Ann. § 21-601 et seq.) at a rate required to produce the amount needed to pay,
8 in addition to the other costs of stormwater management to be paid for from amounts in the
9 Stormwater Management District Fund, for the interest on the Refunding Bonds payable during
10 such fiscal year and the principal of all of the Refunding Bonds maturing or becoming subject to
11 mandatory redemption in each such fiscal year; and in the event the proceeds from taxes so
12 levied in any such fiscal year shall prove insufficient for such purposes, additional taxes,
13 unlimited as to rate or amount, shall be levied and with respect to Refunding Bonds with regard
14 to stormwater management projects, shall be levied within the Stormwater Management District
15 in succeeding fiscal years to make up such deficiency, all as authorized and provided for in Md.
16 Local Government Code Ann. § 21-601 et seq. The County may apply to the payment of the
17 principal of and interest on the Refunding Bonds any funds received by it from the State of
18 Maryland, the United States of America, or any agency or instrumentality thereof, or from any
19 other source, if such funds are granted for the purpose of assisting the County in obtaining public
20 facilities of the class or classes of public facilities for which the Refunded Bonds refunded with
21 the proceeds of the Refunding Bonds issued pursuant to this Act, or the respective portions of
22 such Refunded Bonds, are authorized or may be otherwise lawfully applied to such payment; to
23 the extent that any such funds are applied to such purposes in any fiscal year as provided herein,
24 the taxes hereby required to be levied shall be reduced proportionately.

25 The full faith and credit of the County and the unlimited taxing power of the County are
26 hereby irrevocably pledged both to the punctual payment of the maturing principal of and
27 interest on the Refunding Bonds as and when such principal and interest respectively become
28 due, and to the levy and collection of the taxes hereinabove prescribed as and when such taxes
29 become necessary in order to provide sufficient funds to meet the debt service requirements of
30 the Refunding Bonds. The County hereby solemnly covenants with each of the registered owners
31 of any of the Refunding Bonds to take all action as may be appropriate from time to time during

1 the period that any of the Refunding Bonds remain outstanding and unpaid to provide the funds
2 necessary to make the principal and interest payments on the Refunding Bonds. The debt service
3 requirements of the Refunding Bonds with regard to stormwater management projects, shall
4 have a first and prior claim on all moneys of the Stormwater Management District Fund on a
5 parity with the claim for moneys required for payment of debt service on all other County
6 general obligation stormwater management bonds issued pursuant to the authority contained in
7 Md. Local Government Code Ann. § 21-601 et seq., whether issued prior to or after the issuance
8 of such Refunding Bonds, and the other purposes for which funds in the Stormwater
9 Management District Fund may be disbursed pursuant to Md. Local Government Code Ann. §
10 21-601 et seq. The County further covenants and agrees with each of the registered owners of
11 any of the Refunding Bonds to levy and collect the taxes hereinabove prescribed.

12 In addition, there is hereby pledged to the payment of the interest on and redeeming and
13 paying the Refunding Bonds with regard to stormwater management projects,, as they
14 respectively mature or become subject to mandatory redemption, the Clean Water Act Fees
15 collected by the County in accordance with the Stormwater Acts and deposited in the Local
16 Watershed Protection and Restoration Fund. The debt service requirements of such Refunding
17 Bonds shall have a first and prior claim on all Clean Water Act Fees on deposit in the Local
18 Watershed Protection and Restoration Fund on a parity with the claim for moneys required for
19 payment of debt service on all other County general obligation stormwater management bonds to
20 which such Clean Water Act Fees shall be pledged, and the other purposes for which funds in the
21 Local Watershed Protection and Restoration Fund may be disbursed pursuant to the Stormwater
22 Acts.

23 SECTION 28. BE IT FURTHER ENACTED that, with respect to each series of Refunding
24 Bonds sold pursuant to this Act, authority is hereby conferred on the County Executive to take
25 the following actions and make the following commitments on behalf of the County:

26 (a) in the event any series of Refunding Bonds is sold at private (negotiated) sale as
27 authorized by this Act, to sell such series of Refunding Bonds issued under this Act upon such
28 terms as he or she deems favorable under the existing market conditions to one or more banks,
29 investment banking firms or other financial institutions that, in such official's judgment, offers to
30 purchase such series of Refunding Bonds on terms such official deems favorable to the County
31 under the existing market conditions;

1 (b) in the event any series of Refunding Bonds is sold at private (negotiated) sale as
2 authorized by this Act, to approve, execute and deliver, as a binding and enforceable obligation
3 of the County, an underwriting or purchase agreement for any series of Refunding Bonds issued
4 pursuant to this Act;

5 (c) after considering any recommendations of the financial advisor to the County, if any, to
6 fix and determine the date of any such series of Refunding Bonds, the schedule of annual
7 maturities and/or sinking fund installments of any such series, the amount of any such series, the
8 amounts and particular Refunded Bonds to be refunded with the proceeds of any such series of
9 Refunding Bonds, and the interest rate or rates to be paid by the County with respect to any such
10 series, including, without limitation, the payment dates for the payment of interest with respect
11 to each maturity of any such series and all matters relating to the provision of bond insurance, if
12 any, on all or any portion of the Refunding Bonds;

13 (d) to determine whether the principal of the Refunded Bonds shall be paid at maturity, at
14 the earliest redemption date pertaining thereto, or at some later redemption date;

15 (e) in the event that the County Executive determines that it is in the best interests of the
16 County to sell any such series of Refunding Bonds by soliciting competitive bids at public sale,
17 to determine the date, time and place when proposals for the purchase of any such series of
18 Refunding Bonds will be received, to publish and/or otherwise disseminate a suitable notice of
19 sale or a summary thereof in a manner substantially similar to the procedures for public sale at
20 competitive bidding normally used by the County in connection with the sale of its general
21 obligation bonds, and to award any series of Refunding Bonds for which a legally sufficient
22 proposal has been received to the best bidder;

23 (f) to select and approve the designation of a custodian for a central depository or all
24 matters relating to registration of the Refunding Bonds under a book-entry system;

25 (g) to select a trust company or other banking institution as trustee, to hold the trust fund
26 into which the proceeds of the sale of any Refunding Bonds issued hereunder may be deposited
27 under the Refunding Act, to determine the terms of any such trust fund, including any provisions
28 relating to the payment of costs related to such trust fund, and to approve and deliver as a
29 binding commitment of the County a trust or escrow agreement, pursuant to which such trust
30 fund is established;

31 (h) to determine the manner in which the proceeds of the sale of the Refunding Bonds shall

1 be applied and to provide for the redemption prior to maturity of any of the Refunded Bonds, as
2 applicable, not inconsistent with the provisions of this Act or the Refunding Act; and

3 (i) after considering any recommendations of the County's financial advisor, to reserve to
4 the County the option to redeem or to call for mandatory tender for purchase (and to sell, transfer
5 or convey any such option to call for mandatory tender for purchase) any such series of
6 Refunding Bonds in whole or in part, at such times and upon payment of such premiums as the
7 County's financial advisor may recommend.

8 Subject to and in accordance with the provisions of this Act, the County Executive shall
9 determine for each and every series of Refunding Bonds issued pursuant to and in accordance
10 with this Act, the matters specified in paragraphs (c), (d), (f), (g), (h) and (i) above and, if a
11 determination is made to sell any such series of Refunding Bonds by soliciting competitive bids
12 at public sale, the matters specified in paragraph (e) above for such series of Refunding Bonds.

13 SECTION 29. BE IT FURTHER ENACTED that, to the extent applicable with respect to
14 any of the Authorized Capital Projects, the County is hereby authorized pursuant to this Act and
15 the Maryland Water Quality Financing Administration Act, Sections 9-1601 to 9-1622,
16 inclusive, of the Environment Article of the Annotated Code of Maryland, as amended, replaced
17 or recodified (the "Water Quality Act"), to issue and sell by private sale to the Maryland Water
18 Quality Financing Administration (the "Water Quality Administration") any of the Bonds or
19 Refunding Bonds (or applicable portion thereof) authorized pursuant to this Act in order to
20 evidence a loan or loans (each, the "Loan") made by the Water Quality Administration to the
21 County under one or more loan agreements (each, the "Loan Agreement") between the County
22 and the Water Quality Administration with respect to any of the Authorized Capital Projects.
23 The County Executive is hereby authorized to approve the terms and conditions of and execute
24 and deliver the Loan Agreement on behalf of the County in accordance with the provisions of the
25 Water Quality Act. As authorized by the Water Quality Act and if required by the Water Quality
26 Administration, the County hereby pledges any moneys that the County is entitled to receive
27 from the State of Maryland, including the County's share of the State income tax, to secure its
28 obligations under the Loan Agreement. Any such pledge shall be evidenced and detailed in the
29 Loan Agreement. The Loan Agreement and all the covenants and conditions set forth therein,
30 including, without limitation, the requirement to make payments to the Water Quality
31 Administration of the annual administrative fee, to pay interest at the default interest rate

1 provided for therein, and, if so required by the Water Quality Administration, to establish and
2 maintain a debt service reserve account shall be an obligation of the County in accordance with
3 the provisions of Water Quality
4 Act.

5 SECTION 30. BE IT FURTHER ENACTED that (1) references to "Bonds" in Sections 3,
6 4, 7, 8, 9, 10, 11, 12, 13 and 14 of this Act shall be deemed to include the Refunding Bonds and
7 (2) references to "Bonds authorized by this Act" in Section 14 of this Act shall be deemed to
8 include the Refunding Bonds, unless the context clearly indicates otherwise.

9 SECTION 31. BE IT FURTHER ENACTED that, pursuant to Md. Local Government
10 Code Ann. § 19-204, as amended, replaced or recodified from time to time (the "Registration
11 Statute"), the Bonds, the Notes or the Refunding Bonds issued hereunder may be issued in
12 "registered form" within the meaning of the Registration Statute, as may be determined by the
13 County Executive, who may determine, approve or authorize the selection of trustees, transfer
14 agents, registrars, paying or other agents, a custodian for a central depository or book-entry
15 system and appropriate agreements with any of the foregoing and such other matters not
16 inconsistent with this Act necessary or deemed appropriate in connection with the issuance of the
17 Bonds, the Notes or the Refunding Bonds in "registered form" within the meaning of the
18 Registration Statute.

19 SECTION 32. BE IT FURTHER ENACTED that, the County Executive is hereby
20 authorized, on behalf of the County, to make such undertakings, covenants or agreements for the
21 benefit of the holders of the Bonds, the Notes (including, without limitation, the Program Notes)
22 or the Refunding Bonds, as applicable, with regard to secondary market disclosure as shall be
23 necessary or appropriate to comply with the provisions of Securities and Exchange Commission
24 Rule 15c2-12, as amended, modified or replaced from time to time ("SEC Rule 15c2-12"). Such
25 authority shall include (without limitation) the power to approve and enter into continuing
26 disclosure or dissemination agreements with any third party; the power to amend or modify any
27 such undertakings, covenants, agreements, or continuing disclosure or dissemination agreements,
28 to the extent permitted by SEC Rule 15c2-12; and the power to provide for the insertion of a
29 description regarding any such secondary market disclosure covenants or agreements in any
30 applicable notice of sale, bond purchase agreement or other purchase contract, and any
31 preliminary or final official statement, offering circular, official circular or similar offering

1 document. Such undertakings, covenants or agreements shall be binding upon the County and
2 the County hereby covenants and agrees to abide by any such undertakings, covenants or
3 agreements made in accordance with this Section for the benefit of the holders of the Bonds, the
4 Notes or the Refunding Bonds, as applicable.

5 SECTION 33. BE IT FURTHER ENACTED that pursuant to the authority of Md. Local
6 Government Code Ann. § 19-236, as amended, replaced or recodified from time to time
7 ("Section 19-236"), the County may enter into one or more interest rate exchange agreements or
8 contracts providing for payments based on levels of or changes in interest rates, or combinations
9 of the foregoing, in order to improve the management of debt service or interest rate risks on all
10 or any portion of the Bonds, the Notes or the Refunding Bonds authorized hereby (the
11 "Obligations") or to reduce the cost of servicing all or any portion of such Obligations. Any such
12 interest rate exchange agreement or contract may be entered into in connection with, or
13 incidental to, all or any portion of the Obligations prior to, at the time of, or subsequent to, the
14 issuance of any such Obligations, and may apply to such Obligations and any other general
15 obligation bonds or notes, revenue bonds or notes, or other evidences of indebtedness by
16 whatever name known or funds secured, issued by the County. In connection with any such
17 interest rate exchange agreements or contracts, the County may appoint any agents necessary to
18 implement and administer such agreements or contracts. Unless contrary to the provisions of
19 Section 19-236 or other applicable law, the County Executive is hereby authorized to determine,
20 approve, authorize or provide for, after giving due consideration to the creditworthiness of the
21 counterparty or counterparties and after consulting with the Director of Finance of the County
22 and, if applicable, the financial advisor to the County: (1) the terms and conditions of the
23 transaction, the final form of the agreement or contract and the final terms and conditions of the
24 agreement or contract and (2) the appointment of any agents necessary to implement and
25 administer such agreements or contracts and the terms of compensation therefor. Nothing
26 contained in this Act shall be deemed to preclude the County Council by resolution from making
27 or providing for any of the determinations authorized by Section 19-236. The provisions of this
28 Section shall be liberally construed to effectuate the provisions of Section 19-236.

29 SECTION 34. BE IT FURTHER ENACTED that any and all determinations, approvals,
30 authorizations, decisions, undertakings, specifications, covenants, agreements or provisions (by
31 whatever terminology so specified) authorized to be made by the County Executive pursuant to

1 the provisions of this Act shall be made by order of the County Executive unless otherwise
2 expressly provided herein; provided that, unless contrary to the provisions of the County Charter
3 or other applicable law, the County Executive is hereby expressly authorized to delegate by
4 order to such official or officials designated in such order the power to make any such
5 determinations, approvals, authorizations, decisions, undertakings, specifications, covenants,
6 agreements or provisions or other matters and the manner in which to evidence the same. In
7 addition, unless contrary to the provisions of the County Charter or other applicable law, the
8 County Executive is hereby authorized by order to delegate to one or more appropriate County
9 officials the authority granted to the County Executive by this Act to sign any documents,
10 certificates or instruments, or to specify that one or more appropriate County officials in addition
11 to the County Executive shall sign any such documents, certificates or instruments.

12 SECTION 35. BE IT FURTHER ENACTED that if any one or more of the provisions of
13 this Act, including any covenants or agreements provided herein on the part of the County to be
14 performed, should be contrary to law, then such provision or provisions shall be null and void
15 and shall in no way affect the validity of the other provisions of this Act or of the Bonds, the
16 Notes or the Refunding Bonds.

17 SECTION 36. BE IT FURTHER ENACTED that the provisions of this Act are hereby
18 declared to be severable; and, in the event that any section, subsection, paragraph, subparagraph,
19 sentence, clause, phrase, or word of this Act is declared invalid or unconstitutional by a court of
20 competent jurisdiction, such invalidity or unconstitutionality shall not affect the remaining
21 words, phrases, clauses, sentences, subparagraphs, paragraphs, subsections, or sections of this
22 Act, since the same would have been enacted without the incorporation in this Act of any such
23 invalid or unconstitutional word, phrase, clause, sentence, subparagraph, subsection, or section.

24 SECTION 37. BE IT FURTHER ENACTED that this Act shall take effect forty-five (45)
25 calendar days after it becomes law.

“County Business Day” means any date of the year on which (i) banking institutions in New York, New York or in Maryland are not authorized or obligated by law to remain closed or on which the New York Stock Exchange is not closed or (ii) the offices of the County are not authorized or obligated by law or required by an executive order of the County Executive to be closed.

All payments of the principal of, redemption price and interest on this Bond shall be in such coin or currency of the United States of America as at the time of payment is legal tender for payment of public and private debts.

REFERENCE IS MADE TO THE FURTHER PROVISIONS OF THIS BOND SET FORTH ON THE REVERSE SIDE HEREOF WHICH SHALL FOR ALL PURPOSES HAVE THE SAME EFFECT AS THOUGH FULLY SET FORTH HEREIN.

The full faith and credit and taxing power of Prince George’s County, Maryland are hereby irrevocably pledged to the payment of the principal of this Bond and of the interest payable hereon. To provide for the payment of this Bond, the County is empowered and directed to levy ad valorem taxes upon all the legally assessable property within the corporate limits of the County; such tax levy is subject, however, to the limitation set forth in Section 812 and Section 813 of the County Charter. Section 812 provides, in part, that the County shall not levy “a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979; [except that the County] may levy a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979 if the real property tax rate does not exceed Two Dollars and forty cents (\$2.40) for each One Hundred Dollars (\$100.00) of assessed value.” Section 813 provides that any ordinance or resolution levying or charging taxes or certain fees in excess of the amount levied in the preceding fiscal year shall be referred to a referendum of the qualified voters of the County.

In order to make real property tax bills simpler and easier to understand, the Maryland General Assembly enacted Chapter 80 of the Laws of 2000 providing that, beginning in tax year 2001 (Fiscal Year 2002) property tax for real property shall be applied to 100 percent, instead of 40 percent of the value of the real property and that the real property tax rate shall be adjusted to make the impact of revenue neutral. This State law also provides that any limit on a local real property tax rate in a local law or charter provision shall be construed to mean a rate equal to 40 percent times the rate stated in the local law or charter provision. As a result, the nominal real property rate of the County was adjusted to \$0.96/\$100 of the assessed value in FY 2002. In 2012, Maryland Senate Bill 848 provided, under certain circumstances, for the property tax rate to be set higher than the rate authorized under the County’s Charter. Additional revenue as a result of the increase in the property tax rate is for the sole purpose of funding the approved budget of the local school board. In compliance with such State law, County Council Resolution CR-032-2015 set tax rates for Fiscal Year 2016 (including taxes levied with respect to County general obligation bonds issued prior to the effective date of Charter Section 812 and its predecessors) at \$1.00 for real property and \$2.50 for personal property upon each \$100 assessed value of all assessable property, real and personal, assessed according to the State laws and subject to taxation in the County.

The principal of and interest on this Bond are payable from annual appropriations of the proceeds of ad valorem taxes which the County is empowered and directed to levy, subject to said Section 812 and Section 813 limitations, upon all the legally assessable property within the corporate limits of the County. The County has covenanted, subject to said Section 812 and Section 813 limitations, to levy said ad valorem taxes in rate and amount sufficient for such payment in each fiscal year in which provision must be made for the payment of such principal and interest and in the event the proceeds from taxes so levied in any such fiscal year shall prove inadequate for such payment, to levy additional taxes, subject to said limitation, in succeeding fiscal years to make up such deficiency.

[A portion of the Bonds is being issued for public school facilities. The principal of and interest on this portion of the Bonds are expected to be paid in the first instance from amounts on deposit in a separate school facilities surcharge account established in the County's Capital Projects Fund subject to availability and appropriation for such purpose. In FY 2018 a school facilities surcharge in the amount of \$15,972 is imposed by the County on developing areas outside the beltway and \$9,317 is imposed on developed areas within the beltway for which a building permit is applied (subject to partial exemptions in some regions). The surcharge is subject to adjustment for inflation. The surcharge is collected by the County from the builder at the time a building permit is issued for the dwelling unit. Under State law, the surcharge does not apply to mixed retirement developments, elderly housing, multi-family housing designated as student housing within 1.5 miles of the University of Maryland, College Park Campus, or any property located in an infrastructure-financing district approved prior to January 1, 2000. Pursuant to State law, revenue collected from the school facilities surcharge is required to be deposited in a separate account and can only be used to pay for additional or expanded public school facilities or debt service on bonds issued for such facilities or for new school construction.]

[A portion of the Bonds is being issued for school renovation facilities. The principal and interest on this portion of the Bonds are expected to be paid in the first instance from amounts on deposit in a separate Telecommunication Tax-Supported School Renovation Projects account established in the County's Capital Projects Fund, subject to availability and appropriation for such purpose. Md. Local Government Code Ann. Section 20-605, as amended, authorizes the County to levy and collect a sales and use tax on telecommunication service provided in the County at a rate not less than 5%. The Telecommunication Tax included in the County's Operating Budget for fiscal year 2018 is 9%. Each vendor providing telecommunication service in the County is required to collect the tax on behalf of, and remit the tax to, the County. Of the net proceeds of the revenue from the telecommunications tax, at least ninety percent (90%) is to be used for school system operating expenditures, and the remainder is to be used to pay for capital expenditures for school renovation projects or debt service on the bonds issued by the County for school renovation projects.]

[A portion of the Bonds is being issued for mass transit facilities. The principal and interest on this portion of the Bonds will be payable in the first instance from a separate ad valorem tax levied and collected by the County on behalf of the Washington Suburban Transit Commission ("WSTC"). WSTC is authorized to direct the levy of a property tax on all taxable real and personal property in the County pursuant to the Washington Suburban

Transit District Act (Chapter 870 of the Laws of Maryland, 1965), as amended. The County Attorney is of the opinion that real property taxes levied by WSTC are not subject to the limitations set forth in Sections 812 and 813 of the Charter.]

[A portion of the Bonds is being issued for stormwater management facilities. The principal and interest on this portion of the Bonds will be payable in the first instance from amounts on deposit in the Stormwater Management District Fund ("Stormwater Fund"). The County, by the adoption of CB-__-20__, has covenanted to levy in each fiscal year during which this portion of the Bonds is outstanding a direct ad valorem tax upon all property assessed for the purposes within the Stormwater Management District established pursuant to Subtitle 2 of Title 3 of Article 29 of the Annotated Code of Maryland ("Stormwater District"), at a rate sufficient to produce the amount needed to pay, in addition to the other costs of stormwater facilities to be paid from amounts in the Stormwater Fund, such principal and interest coming due during such fiscal year, and in the event the proceeds from the taxes so levied in any such fiscal year shall prove insufficient for such payment, to levy additional taxes within the Stormwater District in succeeding fiscal years to make up such deficiency.]

[A portion of the Bonds is being issued for solid waste management facilities. The principal and interest on this portion of the Bonds are expected to be paid in the first instance from net income of the County's Solid Waste Enterprise fund, subject to availability and appropriation for such purpose.]

It is hereby certified and recited that each and every act, condition, and thing required to exist, to be done, to have happened, and to be performed precedent to and in the issuance of this Bond, does exist, has been done, has happened and has been performed in full and strict compliance with the Constitution and laws of the State of Maryland, the County Charter, the Authorization Ordinance, the Enabling Acts of the County and the Executive Orders of the County Executive referred to herein, and that the issue of Bonds, of which this Bond is one, together with all other indebtedness of the County, is within every debt and other limit prescribed by the Constitution and laws of the State of Maryland and the County.

This Bond shall not become obligatory for any purpose or be entitled to any benefit under the above-mentioned laws, County Charter, Authorization Ordinance, Enabling Acts or Executive Orders until the Certificate of Authentication hereon shall have been signed by an authorized signatory of the Bond Registrar.

The terms of the Bonds include those stated in the Authorization Ordinances and Executive Orders, and the Bonds are subject to all such terms. The Registered Owner of this Bond is referred to the Authorization Ordinances and the Executive Orders for a complete statement of such terms, to which the Registered Owner hereof, by acceptance of this Bond, assents.

The Bonds maturing in any one year are issuable in fully registered form, in denominations of \$5,000 or any integral multiple thereof, not exceeding the aggregate principal amount maturing in such year.

The County will provide services as Bond Registrar to open books for the registration and for the transfer of registered Bonds. This Bond will be transferable only upon the Bond Register kept at the Office of the Director of Finance of the County by the Registered Owner in person, or

by his or her attorney duly authorized in writing, upon surrender together with a written instrument of transfer in the form attached hereto and satisfactory to the Bond Registrar duly executed by the Registered Owner or duly authorized attorney.

This Bond may be transferred or exchanged at the office of the Bond Registrar. Upon any such transfer or exchange, the County shall issue a new registered Bond or Bonds of any of the authorized denominations in aggregate principal amount equal to the principal amount of the Bond transferred or exchanged or the unredeemed portion thereof, and maturing on the same date and bearing interest at the same rate. In each case, the Bond Registrar may require payment by the Registered Owner of this Bond requesting exchange or transfer hereof of any tax, fee or other governmental charge, shipping charges and insurance that may be required to be paid with respect to such exchange or transfer, but otherwise no charge shall be made to the Registered Owner hereof for such exchange or transfer. Said new Bond or Bonds will be delivered to the transferee only after due authentication thereof by any authorized signatory of the Bond Registrar. The Bond Registrar shall not be required to transfer or exchange any Bond after the mailing of a notice calling such Bond for redemption has been made, or during the period of fifteen (15) days next preceding mailing of a notice of redemption.

The County may deem and treat the person in whose name this Bond is registered as the absolute owner hereof for the purpose of receiving payment of or on account of the principal or redemption price hereof and interest due hereon and for all other purposes.

If fewer than all of the Bonds shall be called for redemption, the particular maturities of the Bonds or portions thereof to be redeemed shall be selected by the County. If fewer than all of the Bonds of any maturity shall be called for redemption, the particular Bonds or portions of Bonds to be redeemed shall be selected by lot or in such manner as the Bond Registrar and Paying Agent, at its discretion, may deem proper.

When less than all of a registered Bond in a denomination in excess of \$5,000 shall be so redeemed, then, upon the surrender of such Bond, there may be issued to the Registered Owner thereof, without charge, for the unredeemed balance of the principal amount of such Bond, at the option of such Registered Owner, registered Bonds in any of the authorized denominations, the aggregate face amount of such Bonds not to exceed the unredeemed balance of the registered Bond so surrendered, and to bear the same interest rate and to mature on the same date as said unredeemed balance.

If, in accordance with the foregoing option, the County elects to redeem all outstanding Bonds, or less than all, it will give notice described herein of its intention to redeem by letter mailed first class, postage prepaid, to the Registered Owners of such Bonds at least thirty (30) days prior to the date fixed for such redemption, at the addresses of such Registered Owners appearing on the Bond Register kept by the Bond Registrar; provided, however, that the failure to mail such notice or any defect in the notice so mailed, or in the mailing thereof shall not affect the validity of the proceedings for the redemption of the Bonds for which notice was properly

given. Said notice shall state for all Bonds being redeemed: the maturity date, certificate numbers, redemption date, redemption price, the address of the office of the Bond Registrar and Paying Agent with a contact person and telephone number, whether the Bonds are being redeemed in whole or in part and shall also state that the interest on the Bonds so called shall cease to accrue on the date fixed for redemption and shall require that the Bonds so called be presented for redemption and payment at the office of the Paying Agent.

From and after the date fixed for redemption, if due notice has been given as herein provided, and the funds sufficient for payment of the redemption price and accrued interest shall be available therefor on such date, the Bonds so designated for redemption shall cease to bear interest.

Upon presentment and surrender in compliance with said notice, the Bonds so called for redemption shall be paid by the Paying Agent at the redemption price plus any accrued interest. If not so paid on presentment thereof, said Bonds so called shall continue to bear interest at the rates expressed therein until paid. All Bonds redeemed and paid hereunder will be canceled.

Registration Under DTC Book - Entry Only System

In addition, DTC or such replacement depository may determine to discontinue its services as a securities depository or the County may determine to discontinue a system of book-entry only registration of the Bonds, in which event Bonds will be delivered in authorized denominations of \$5,000 and integral multiples thereof to or at the direction of the participants of the then existing securities depository.

If fewer than all of the Bonds of any maturity shall be called for redemption, the particular Bonds or portions of Bonds to be redeemed shall be selected by lot or in such manner as the Bond Registrar and Paying Agent, at its discretion, may deem proper.

Authority to Issue: The Bonds are being issued under the authority of Section 10-203 of the Local Government Article of the Annotated Code of Maryland (2013 Replacement Volume and 2016 Supplement), as amended (the "Enabling Law"), the County Charter, the Authorization Ordinances identified in the next sentence, the bond enabling laws cited in the Authorization Ordinances (the "Enabling Acts") and certain orders of the County Executive. The following

County Council Bills provide authority for the Bonds: CB-_____ (collectively, the "Authorization Ordinances").

Purpose: The Bonds are being issued to provide funds for financing, in whole or in part, the costs of planning, construction, reconstruction, establishment, extension, enlargement, demolition, improvement or acquisition of certain capital projects, including public school facilities, roads and bridges, libraries, community college facilities, fire stations, stormwater management facilities, environmental resource facilities, solid waste facilities, mass transit facilities, health facilities and County buildings.

Sources of Payment: The County has pledged its full faith and credit and taxing power for the payment of the principal of and interest on the Bonds. To provide for the payment of the Bonds, the County is empowered and directed to levy ad valorem taxes upon all legally assessable property within the corporate limits of the County; such tax is subject, however, to the limitations set forth in Sections 812 and 813 of the County Charter. Section 812 provides, in part, that the County shall not levy "a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979; [except that the County] may levy a real property tax which would result in a total collection of real property taxes greater than the amount collected in fiscal year 1979 if the real property tax rate does not exceed Two Dollars and forty cents (\$2.40) for each One Hundred Dollars (\$100.00) of assessed value." Section 813 provides that any ordinance or resolution levying or charging taxes or certain fees in excess of the amount levied or charged in the preceding fiscal year shall be referred to a referendum of the qualified voters of the County. In the 2000 legislation session, the State legislature enacted a law providing that beginning fiscal 2002, the property tax for real property shall be applied to 100 percent, instead of 40 percent, of the phase-in value of the real property and that the tax rate shall be adjusted to make the impact revenue neutral. Such State law also provides that any limit on a local real property tax rate in a local law or charter provision shall be construed to mean a rate equal to 40 percent times the rate stated in the local law or charter provision. Pursuant to this new law, the tax rate is \$0.96 for real property and \$2.40 for personal property upon each \$100 assessed value of all assessable property, real and personal, assessed according to the State law and subject to taxation in the County.

Delivery and Payment: The Bonds will be delivered at ___:___ a.m. prevailing Eastern Time on ____ __, 20__* or at such other time or on such earlier or later date as shall be mutually agreed upon by the County and the successful bidder (the "Closing"), at the expense of the County, at the offices of DTC in New York, New York, or at such other place as shall be mutually agreed upon by the County and the successful bidder, upon payment of the amount of the successful bid (including any premium), plus accrued interest to the date of delivery, less the amount of the good faith deposit. Such payment shall be made in federal funds by wire transfer to a designated bank account of the County. At the time of Closing, there will be delivered to the successful bidder the other closing documents hereinafter mentioned and the successful bidder will provide evidence satisfactory to the County that funds have been transferred and are immediately available to the County. It is anticipated that separate CUSIP identification numbers for each maturity will be printed on the Bonds, but neither the failure to print any such number on any bond nor any error with respect thereto shall constitute cause for a failure or refusal by the successful bidder to accept delivery of and pay for the Bonds in accordance with the terms of this Notice of Sale.

When delivered, the Bonds shall be duly executed and authenticated and registered in the name of Cede & Co., the partnership nominee of DTC, with one Bond representing each maturity of the Bonds, each in the aggregate principal amount of such respective maturity.

The Bonds may be inspected by the successful bidder at the office of DTC at least one business day prior to Closing.

Legal Opinion: The issuance of the Bonds will be subject to legal approval by _____ whose approving opinion will be delivered upon request, without charge, to the successful bidder for the Bonds.

Official Statement: Within seven (7) business days after the award of the Bonds to the successful bidder on the date of sale, the County will authorize and deliver to the successful bidder an Official Statement, which is expected to be substantially in the form of the Preliminary Official Statement referred to below. If so requested by the successful bidder at or before the close of business on the date of the sale, the County will include in the Official Statement pricing and other information with respect to the terms of the reoffering of the Bonds by the successful bidder (the "Reoffering Information"). If no Reoffering Information is specified and furnished by the successful bidder, the Official Statement will include the interest rates on the Bonds resulting from the bid of the successful bidder and the other statements with respect to reoffering contained in the Preliminary Official Statement. The successful bidder shall be responsible to the County and its officials for the Reoffering Information, and for all decisions made by the successful bidder with respect to the use or omission of the Reoffering Information in any

reoffering of the Bonds, including the presentation or exclusion of any Reoffering Information in any documents, including the Official Statement. The successful bidder will also be furnished, without cost, with up to 300 copies of the Official Statement (and any amendment or supplement thereto that is prepared other than as a result of incorrect underwriting information or Reoffering Information furnished by the successful bidder or that is prepared because of a failure of the successful bidder).

The County will undertake to provide the successful bidder with further additional information to be included in such Official Statement when, in the opinion of the County or of Bond Counsel, such additional information constitutes a material change to such Official Statement. The County will take such steps as are necessary to arrange for amending and supplementing the Official Statement in connection with the disclosure of such additional information; provided, however, that the County shall have no obligation to provide such additional information after the date which is 25 days after the "end of the underwriting period," as such term is defined in Securities and Exchange Commission Rule 15c2-12. The successful bidder for the Bonds agrees to provide promptly copies of the Official Statement to a nationally recognized municipal securities information repository in accordance with Securities and Exchange Commission Rule 15c2-12.

Continuing Disclosure: In order to assist bidders in complying with Rule 15c2-12(b)(5) of the Securities and Exchange Commission, the County will undertake, pursuant to a Continuing Disclosure Certificate, to provide (i) certain financial information and operating data annually, and (ii) notices of the occurrence of certain events, if material. A description of this undertaking is set forth in the Preliminary Official Statement and also will be set forth in the final Official Statement.

It shall be a condition to the obligation of the successful bidder to accept delivery of and pay for the Bonds that simultaneously with or before delivery and payment for the Bonds, such successful bidder shall be furnished with a fully-executed copy of the Continuing Disclosure Certificate.

Closing Documents: The Bonds will be accompanied by customary closing documents, including a no-litigation certificate, effective as of the date of delivery, stating that there is no litigation pending affecting the validity of the Bonds.

It shall be a condition to the obligation of the successful bidder to accept delivery of and pay for the Bonds that simultaneously with or before delivery and payment for the Bonds such successful bidder shall be furnished a certificate of the appropriate County officials to the effect that to the best of their knowledge and belief, the Official Statement (and any amendment or supplement thereto) (except for the Reoffering Information, information concerning DTC and its book-entry system, and information regarding any municipal bond insurance obtained with respect to the Bonds, as to which no view will be expressed) as of the date of sale and as of the date of delivery of the Bonds does not contain any untrue statement of a material fact and does not omit to state a material fact necessary to make the statements therein, in light of the circumstances under which they were made, not misleading, and that between the date of sale and the date of delivery of the Bonds there has been no material adverse change in the financial position or revenue of the County, except as reflected or contemplated in the Official Statement.

If the County advises the bidders that the bid for the Bonds constitutes a Qualified Competitive Bid, the winning bidder shall be required to provide to the County information to establish the initial expected offering prices for each maturity of the Bonds for federal income tax purposes by completing a certificate acceptable to Bond Counsel in substantially the form set forth in Exhibit [A-1] to the Preliminary Official Statement, with appropriate completions, amendments and attachments.

If the County advises the bidders that the bid for the Bonds constitutes a Nonqualified Competitive Bid, the winning bidder shall be required to provide to the County information and assurances to establish the initial sale prices or the initial offering prices, as applicable, for each maturity of the Bonds for federal income tax purposes by completing a certification acceptable to Bond Counsel in substantially the form set forth in Exhibit [A-2] to the Preliminary Official Statement, with appropriate completions, omissions and attachments.

The successful bidder for the Bonds, by submitting its bid, agrees to provide a comparative coupon and yields statement for an uninsured transaction if it bids with insurance.
