#### 135 Provided:

- (A) The property included within the Preliminary Plan of Subdivision fronts on roadways with a functional transportation classification of arterial or higher and collector or higher within the applicable Master Plan; and
- (B) The property included within the Preliminary Plan of Subdivision is zoned both R-T and R-18C.
- A Detailed Site Plan shall be approved in accordance with Part 3, Division 9, of this Subtitle. Regulations of the R-T and R-18C Zones shall not apply; all requirements for development shall be established by and shown on the Detailed Site Plan approved by the Planning Board and/or the District Council. The proposed Gas Station use shall conform with all regulations set forth in Section 27-358 (a) and (b) of this Subtitle. Upon abandonment of the Gas Station, as defined in Section 27-358(c), the owner shall remove all structures, including underground storage tanks.
