RESOLUTION

A RESOLUTION concerning

The Washington Suburban Sanitary Commission Fiscal Years 2021-2026
Capital Improvements Program and Fiscal Year 2021 Capital Budget
for Prince George's County for Water and Sewerage

For the purpose of adopting with amendments the WSSC Fiscal Years 2021-2026 Capital Improvements Program and Fiscal Year 2021 Capital Budget for Water and Sewerage.

WHEREAS, Section 23-304 of the Public Utilities Article, Annotated Code of Maryland, requires the Washington Suburban Sanitary Commission (hereinafter "WSSC") to submit before October 1 of each year a Capital Improvements Program to the County Executive for Prince George's County; and

WHEREAS, Section 23-304 of the Public Utilities Article, Annotated Code of Maryland, requires the County Executive to transmit said Program together with comments, recommendations, and suggested amendments to the Prince George's County Council; and

WHEREAS, this Capital Improvements Program must contain, at a minimum, major projects as that term is defined in Section 23-301 of the Public Utilities Article, Annotated Code of Maryland, including water and sewerage projects; and

WHEREAS, this WSSC Capital Improvements Program is part of the Adopted County Comprehensive Ten-Year Water and Sewerage Plan and contains projects to support water supply and sewerage system development as proposed in the Plan; and

WHEREAS, in accordance with Section 17-202 of the Public Utilities Article, Annotated Code of Maryland, the WSSC did timely submit to the County Executives of Prince George's and Montgomery Counties the record of the public hearing held by the Commission on the said

Capital Improvements Program; and

WHEREAS, the WSSC has delivered its Capital Improvements Program to the County Executive; and

WHEREAS, the Prince George's County Executive has transmitted to the Prince George's County Council, the WSSC Capital Improvements Program, together with such comments and recommendations as were deemed appropriate; and

WHEREAS, Section 23-306 of the Public Utilities Article, Annotated Code of Maryland, further provides that after notice, the County Council shall approve, disapprove or modify the WSSC Capital Improvements Program provided that the WSSC is afforded an opportunity to comment on suggested modifications; and

WHEREAS, the Montgomery and Prince George's County Councils concurred with the recommended changes at the May 7, 2020 Bi-County Meeting; and

WHEREAS, all other requirements of Section 23-306 of the Public Utilities Article, Annotated Code of Maryland, that concern final action by the Council on the WSSC Capital Improvements Program for Water and Sewerage have been met.

BE IT RESOLVED by the County Council of Prince George's County, Maryland, that the Capital Improvements Program Fiscal Years 2021-2026 and the FY 2021 Capital Budget as transmitted by the County Executive, are hereby adopted as amended by the attached Appendices, copies of which are attached hereto and incorporated herein by reference as though they were set forth fully herein, identified as Appendix A and Appendix B.
