Legislative Summary

CB-17-2020, sponsored by Council Chair Turner was presented on May 18, 2020 and referred to the Committee of the Whole. CB-17-2020 would repeal the license requirements for Television and Radio Repair facilities.

Background/Current Law:

Subtitle 24A of the County Code currently requires a license for operators of Television and Radio repair facilities and operations. A "Television and Radio Equipment Repair Facility" is defined as "any business entity operated for financial profit which engages in the business of installing, servicing, diagnosing, rebuilding, reconditioning, or inspecting television and radio equipment."¹ Applications for licenses are made to the Director of the Department of Permitting, Inspections, and Enforcement² accompanied by a fee of \$75³ and a \$2,000 bond.⁴ The current law outlines the protocols for application, inspections of facilities, and protocols for denials, appeals, suspensions and enforcement.

Policy Analysis

• Potential Benefits of Repealing of the License Requirement

As DPIE begins to revamp its permitting processing, the Department has been looking to streamline and repeal any outdated license requirements to ensure a more efficient and fair system for residents and businesses. In reviewing the license for Television and Radio Repair Operators, it was determined that there has been only one application in the past five (5) years and the County has only one (1) licensed television and radio repair operator. As such, the Department believes the license is no longer necessary.

• Potential Costs of Repealing of the License Requirement

Repealing the license requirement for Television and Radio Repair Facility would eliminate County regulation of these businesses. The requirement was put in place in 1974 and has only had minor substantive amendments since then. The reasons for the implementation of the requirement may no longer be present, and given the small number of such businesses licensed each year, it may be appropriate to eliminate the requirement

Fiscal Impact:

Direct Impact

Enactment of CB-17-2020 will result in minimal negative fiscal impact on the County in the amount of lost application fee revenue. The average annual revenue from the application fees over the last five (5) has been less than \$1,000.
