RESOLUTION

A RESOLUTION concerning

FY 2020-2029 Comprehensive Ten Year Solid Waste Management Plan For the purpose of adopting the Prince George's County FY 2020-2029 Ten Year Solid Waste Management Plan as recommended by the County Executive.

WHEREAS, Title 9, Subtitle 5 of the Environment Article of the Annotated Code of Maryland requires the County to adopt and submit to the Maryland Department of the Environment a comprehensive plan dealing with solid waste disposal systems, and solid waste acceptance facilities every ten years; and

WHEREAS, Title 9, Subtitle 5 of the Environment Article of the Annotated Code of Maryland provides procedures governing the preparation and adoption of the plan, and provides for amendments and revisions thereto; and

WHEREAS, pursuant to said procedures, the County Executive submitted to the County Council a proposed FY 2020-2029 Comprehensive Ten Year Solid Waste Management Plan (the "Plan") to update the FY 2017-2026 Comprehensive Ten Year Solid Waste Management Plan; and

WHEREAS, the County Council received testimony through an advertised public hearing; and

WHEREAS, the County Council notified the municipalities, the Washington Suburban Sanitary Commission, the Maryland-National Capital Park and Planning Commission, and the Maryland Department of the Environment of the public hearings and provided each agency with copies of the proposed Plan.

NOW THEREFORE, BE IT RESOLVED by the County Council of Prince George's

County, Maryland, that the document titled "Draft" and attached hereto is hereby adopted as the Prince George's County FY 2020-2029 Comprehensive Ten Year Solid Waste Management Plan, as amended.

BE IT FURTHER RESOLVED that the adopted Prince George's County FY 2017-2026 Ten Year Solid Waste Management Plan is repealed and superseded.

BE IT FURTHER RESOLVED that within five (5) working days of the adoption of this resolution, it shall be transmitted to the County Executive by the Clerk of the Council.

BE IT FURTHER RESOLVED by the County Council of Prince George's County, Maryland, that this Resolution shall take effect on the day following the first regularly scheduled Council meeting day which occurs after the County Executive transmits her comments on this Resolution, or on the day that the County Executive indicates she has no comments, or ten (10) working days following transmittal of this Resolution to the County Executive, whichever shall occur first. Prior to the effective date of this Resolution, the Council may reconsider its action based upon any recommendation received from the County Executive.

BE IT FURTHER RESOLVED that upon the effective date of this Resolution, it shall be transmitted by the Clerk of the Council to the Secretary of the Maryland Department of the Environment.
