EXPLANATION OF ADJUSTMENTS

Non-Departmental

The Maryland Department of Commerce COVID-19 Restaurant Assistance Program awarded \$6,105,099 for the Restaurant Relief Fund grant that will be implemented by the Economic Development Corporation. Funding will enable the County to issue grants to restaurants to promote and encourage stabilization within the hospitality and restaurant industry. Grant proceeds from the program include: working capital, such as rent, payroll, and job training; purchase of equipment and services to expand outdoor dining, such as tents, heaters, warmers, and carts; infrastructure improvements, such as heating, ventilation, and air conditioning (HVAC) system upgrades; technology to support carryout and delivery; purchase of personal protective equipment (PPE) and disposable food containers and utensils; and sanitization services.
