BACKGROUND INFORMATION/FISCAL IMPACT:

This bill will extend the validity periods of approved detailed site plans and specific design plans in light of the COVID pandemic public health emergency and related economic impacts and resultant delays in the public approval process of the Countywide Map Amendment. The bill will approve a one-year extension for plans in a valid status that were approved prior to January 1, 2015, and a two-year extension for plans in a valid status that were approved after January 1, 2015.
