BACKGROUND INFORMATION/FISCAL IMPACT:

This bill will codify the provisions of CB-15-2018, also known as Chapter 85, 2018 Laws of Prince George's County, Maryland, in order to reflect the Council's enactment of a new County Subdivision Regulations Code, as required by law. Although the provisions of the new County Subdivision Regulations must be reflected by Charter, the provisions themselves will not take effect until the Council approves a Countywide Map Amendment in accordance with law.
