I am requesting that these cases be remanded to the Zoning Hearing Examiner for clarification of what we consider to be errors on the following two outstanding issues:

- Mr. Norman Rivera's appeal request that "the primary exception is to request that the order reinstate Condition No. 6 of A-10020-C which states as follows: "All required transportation facility improvements shall be determined at the time of subdivision approval."
- The Lake Arbor Civic Association's appeal is submitted in disagreement with the ZHE's recommendation/decision made in Condition 5b (page 22) which nullifies the decision made by the District Council in Case No. DSP -18024 decided on May 30, 2019. The ZHE's decision states that: the I-310/Grand Way Boulevard: (will be) Construct(ed) the entire roadway between MD 202 and Ruby Lockhart Boulevard within the dedicated right-of-way to County standards and the District Council's decision No. 3 on page 13 states: Applicant shall revise the site plan to show right-of-way along I-308 (Ruby Lockhart Boulevard) and I-310 (the ramp/roadway linking Ruby Lockhart and MD 202) consistent with Master Plan
