BACKGROUND INFORMATION/FISCAL IMPACT:

This bill will define a new use, Farm brewery, and it will amend the Residential Table of Uses Permitted to allow Farm Brewery uses in the O-S Zone, consistent with provisions of the Alcoholic Beverages Article of State law and subject to additional specified local zoning requirements in furtherance of the public safety, health, and welfare.
