COVID RESTRICTIONS UPDATE

Tara H. Jackson, Chief Administrative Officer Ernest Carter, MD, Ph.D Health Officer Rhonda Weaver, County Attorney

Tara Jackson, CAO, provided a brief overview of the changes being made by the County Executive as a result of the new Governor's Order. Rhonda Weaver, County Attorney outlined the changes to align the County with State regulations excepting the indoor mask order. Dr. Ernest Carter provided further details of the factors that contributed to this decision.

The Panelists responded to questions posed by Council Members regarding public awareness and timeline of vaccinations for 12 to 15 year olds; better vaccination strategies; new strain from India; masking; sports venues; enforcement; conventions at Gaylord; new Executive Order to amend the recently adopted CR-048-2021; Fed-Ex field; churches and readiness for opening schools in the fall.
