Committee Vote: Favorable 10-0 (In favor: Council Members Hawkins, Davis, Dernoga, Franklin, Glaros, Harrison, Ivey, Streeter, Taveras and Turner)

The Committee convened on June 17, 2021 to review the resolution authorizing the Director of the Prince George's County Department of Public Works and Transportation to file applications for Fiscal Year 2022 with the Maryland Department of Transportation (MDOT), U.S. Department of Homeland Security (DHS), U.S. Department of Transportation (USDOT), Federal Transit Administration (FTA) and the Metropolitan Washington Council of Governments (MWCOG) for a variety of state and federal grant programs. CR-63 endorses DPWT's applications for the following grants:

MDOT

The Maryland Transit Administration (MTA) - under the Federal Transit Act:

DPWT staff (Martin Harris - Deputy Director, Semia Hackett – Associate Director and Marisol Peralta - Community Developer II) provided comments on the evolution of the grants application process, which is becoming more stream-lined. CR-63-2021 also authorizes the application for the apportionment for the Washington, DC/VA/MD urbanized area, which is being administered through the Metropolitan Washington Council of Governments (MWCOG), s well as any additional or remaining funding from the CRSSA, the Coronavirus Aid, Relief, and Economic Security (CARES) Act, the American Rescue Plan Act of 2021, or other unanticipated Federal funding programs that would require application during Fiscal Year 2022.

After the discussion, the Committee voted favorably on CR-63-2021 by a vote of 10-0.
