ORDER REVERSING DISMISSAL AND REMAND TO ZONING HEARING EXAMINER

IT IS ORDERED, after a hearing and upon consideration of a written appeal from

Examiner's Order of Dismissal on August 21, 2019, in Special Exception 4694, a request to obtain

a use and occupancy permit to validate an existing church and building additions without building

permits, in the R-18 (Multifamily Medium Density Residential) Zone, on land located on the

southern side of Marlboro Pike (MD 725), approximately 2,000 feet east of its intersection with

Penn Crossing Drive, Forestville, Maryland, in Councilmanic District 7, that Examiner's Order of

Dismissal is hereby REVERSED and REMANDED for further processing. PGCC § 27-128.

On remand, and at the direction of the Examiner, the applicant shall finalize the application

for further processing. After further processing of the application on remand, including any

additional evidentiary hearing, the Examiner shall render a disposition recommendation subject to

the relevant provisions of the County Code and the Land Use Article.
