(b) TABLE OF USES.

- **143** Notwithstanding any other provision of this Subtitle, a nursing or care home is permitted use without the requirement for a Special Exception, and any previously approved Special Exception shall not be of any force or effect for a nursing or care home, provided:
 - i. the use was initially developed as part of a prior Special Exception for a medical/residential campus; and
 - ii. with the exception of providing fencing (which may include a gate) and landscaping pursuant to the requirements of the Landscape Manual, any exterior alterations or changes to an existing nursing or care home shall be subject to Detailed Site Plan approval pursuant to Part 3 Division 9 of this Subtitle.
