On behalf of the Prince George's County Council, I am writing to offer my full support for the Prince George's County Department of Public Works & Transportation's (DPW&T) application for a discretionary grant funding through the U.S. Department of Transportation (USDOT), Federal Transit Administration's (FTA) "*Buses and Bus Facilities Program.*"

Improving the safety and reliability of *TheBus* public transit in Prince George's County, Maryland is imperative. Approval of this application will provide much needed funding to enable the purchase of additional battery electric buses and related charging infrastructure. If awarded, Prince George's County plans to apply these resources to expanding daily bus service in underserved parts of the County, where riders access jobs, healthcare and other vital services while improving air quality and promoting environmental justice.
