Hawi Sanu, Director of the Transportation Housing and The Environment Committee (THE), provided an overview of the Legislation and responded to questions posed by the Council. Council Member Davis moved to reconvene as C.O.W.; seconded by Council Member Olson. Council Member Lehman moved amendment; seconded by Council Member Olson. The motion carried 8-0 (Absent Council Member Turner) The main motion for adoption of Council Resolution 39 was including the amendment carried 8-0.
