Director Eric C. Brown provided an overview of the Comprehensive Housing Strategy project and Introduced Mr. Chris Kizzie, Enterprise Community Partners. The goals of the project is to define policies and strategies, facilitate data-driven decision making, leverage current and planned economic development and communicate a clear and realistic implementation plan. A comprehensive housing strategy will integrate housing market conditions, needs and considerations related to access to opportunity using a comprehensive framework. This a 3 phase project; approaching the end of Phase 1. Ms. Anne Jordan provided the Council with an explanation of planned outreach and community activities as well as already completed public hearings held at Oxon Hill High School and Central High School. Ms. Laura Searfoss, spoke to the County conditions observed to date and proposed strategies. Mr. Kizzie expanded on the strategy options to strengthen neighborhoods and improve quality of life.
