Dr. Alvin Thornton provided an historical perspective of the recommendations of the Thornton Commission, whose work proceeded this effort. The Honorable Paul Pinsky, Maryland State Senator, Legislative District 22, and The Honorable Alonzo Washington, Maryland State Delegate, Legislative District 22, facilitated a PowerPoint presentation on the Maryland Commission on Innovation and Excellence in Education (Kirwin Commission) focusing on areas of preliminary policy recommendations, areas of consensus, and Fiscal Accountability. Dr. Kevin M. Maxwell, CEO of Prince George's County Public Schools, expressed his support for the Kirwin Commission's recommendations and spoke to current regulations which do not fully consider services for Pre-kindergarten students. Theresa Dudley, President, Prince George's County Educators Association offered a video presentation on the "community school" concept and provided comments regarding the concept, standardized testing, wrap-around services, parental support and administration. Kimberly R. Humphrey, Legislative Council for the ACLU for Maryland spoke to litigation which led to a review of adequacy standards across the State and provided a summary of the adequacy gap in Prince George's County. The

panelists responded to questions posed by the Council regarding: lessons learned from the Thornton Commission, methods to improve State ranking, accountability, potential for State Inspector General, Career and Technical Education programs, growth in adequacy gap, navigating a change in formula and ways to address schools that may need additional system.
