Jacqueline Brown, provided introductory remarks. Derek Berlage and Chad Williams, provided a walk-through of Attachment "A" of the CB-15-2018 and responded to questions posed by the Council and panelists regarding: definition of development, conversion of uses, applicability to existing subdivisions or only those approved after adoption of the new regulations, amendment of prior approvals, consolidation of lots, conveyance of land, expansions, exemptions, who determines findings with regard to state and federal regulations, grandfathering, validity periods, building restriction

lines, variances from intensity, procedures, fees, pre-application meeting, potential timeframes, registration of civic associations, major and minor subdivisions, ownership lots, variations, rationale for distinction, proper threshold, traffic impact study submittal, expedited processes for transit oriented development, zero lot line development, interpretations, County newspaper(s) of record, plat of computation, approval deadlines, applicability of State Land Use Article, zoning ordinance standards (i.e. architecture, lots, grading, etc.), standards versus guidelines, view-shed, access to easements, determination of "maximum extent possible/practicable," lighting techniques language, applicability to public roads and private roads, comparison to road and circulation standards, connectivity, comportment with 10-year Water and Sewer Plan, Adequate Public Facilities review/approval, certificate of adequacy approval procedures/proposed regulations, pedestrian/bikeway adequacy standards, related automatic re-zonings, and school adequacy test and impact fee/surcharge. Chair Glaros summarized items for review at a subsequent meeting.
