### <u>CB-028-2017</u> <u>AN ORDINANCE CONCERNING HOTEL OR MOTEL USES IN</u>

<u>COMMERCIAL ZONES</u> for the purpose of amending the commercial table of uses in the Zoning Ordinance to prohibit Hotel or Motel uses located within 1,000 feet of an existing power distribution plant or substation, in furtherance of the public safety, health, and welfare of the citizens and residents of Prince George's County.
