The briefing was convened by Chair Turner at 2:25 p.m. Jackie Brown, Director of the Planning, Zoning and Economic Development Committee (PZED), provided an overview of the materials provided to Council for consideration during this budget work-session. Elizabeth Hewlett, Planning Board Chair, provided introductory remarks. Dan Conforti, Acting Director of Parks and Recreation, provided brief comments as well. Aaron Waller, CIP Budget Manager, provided an overview of the binder of Parks and Recreation Capital Projects. The panelists responded to questions posed by the Council regarding: National Harbor revetment and the related public safety pier and facility, Tucker Road Ice Rink, South Tech Recreation Center Aquatic Center Pool, imagination and theme playgrounds, turf fields, potential amphitheatre, trail funding, natural surface trails in Cosca Park, multi-generational centers, extending summer programming, public transportation access, micro-transit in South county, Wilmer's Park and Formula 2020 implementation. Elizabeth Hewlett, Chair of the Planning Board, and John Crawl, spoke to the Central Administrative Services budget and outlined potential budget cuts as requested by the Montgomery County, County Executive and responded to questions posed by the Council.
