Council Chair Turner provided opening remarks and announced the release of the Report of the Rand Study titled "Assessing Health and Human Services Needs to Support An Integrated Health in All Policies Plan for Prince George's County." Robert J. Williams, Jr., Council Administrator, provided an overview of the work done to arrive at this point. The Council Chair introduced the panelists. Anita Chandra, Dr.P.H. and Ashley Kranz, PhD of the RAND Corporation facilitated a PowerPoint Presentation titled "Moving Forward - Implementing a Health in All Policies Plan in Prince George's County", focusing on the Health of County Residents; Describe drivers of Health Across Social, Economic and Environmental Contexts and Offer Recommendations for Health in All Policies. Also outlined were methods of calculating data; Health Consequences of COVID-19; High Rates of Uninsured Citizens; Systemic Racism; Funding Alignment and Equity; Social Determinants of Health and High Vulnerability Levels. Dr. Fullum and Dr. Hancock provided further comments. The panelists responded to questions posed by Council Members regarding asthma rates, prison data, teen birthrate, priority areas, vulnerability areas, federal impact over the long term, grant money, social vulnerability index, County resources map, infrastructure, health impact studies, health expectancies and rate of uninsured.
