EXECUTIVE SESSION NOVEMBER 5, 2020

The County Council convened in Executive Session on November 5, 2020, at 3:32 p.m. in accordance with Section 3-305(b)(7) of the General Provisions Article to consult with counsel to seek legal advice. Members present were Council Chair Todd M. Turner, Vice Chair Calvin S. Hawkins, Council Member Monique Anderson-Walker, Council Member Derrick Leon Davis, Council Member Thomas E. Dernoga, Council Member At-Large Mel Franklin, Council Member Dannielle M. Glaros, Council Member Sydney J. Harrison, Council Member Jolene Ivey, Council Member Rodney C. Streeter, and Council Member Deni L. Taveras. Staff members present were Council Administrator Robert J. Williams, Jr., Deputy Council Administrator William M. Hunt, Clerk of the Council Donna J. Brown, Communications Director Karen D. Campbell, Chief Zoning Hearing Examiner Maurene Epps McNeil, Principal Counsel Rajesh Kumar, and Staff Attorney Karen Zavakos.

Members were advised by counsel present that statutorily required public ethics affidavits were collected in the manner prescribed by law. Based on the information contained therein, State law would prohibit a majority if not all of the Council Members from participating in the consideration of any part of the Countywide Map Amendment hearing and approval process that is currently underway. Counsel advised of various options to move forward, including a statement to postpone the scheduled joint public hearing until further clarification from State entities can be sought and received. After discussion amongst Members and questions and answers provided with staff, the Council voted as follows: Motion to direct staff and leadership to expeditiously explore the following options (Motion by DLD, seconded by DLT)

1. Notify our partners involved in the Countywide Map Amendment process that there is a need to postpone the joint public hearing scheduled for November 19, 2020, and prepare a public statement of same with explanation;

 Direct legal staff to seek input and advice from the State Ethics Commission concerning the current posture of the process; and
 To begin discussions needed to pursue a legislative dispensation from the Maryland General Assembly

The Motion carried 11-0.

Upon motion, the Council unanimously voted to adjourn and the closed session concluded at 4:36 p.m.
