The Council Chair provided opening comments regarding the need for CR-121-2020 and introduced Rhonda Weaver, County Attorney; Ernest Carter, MD, Ph.D Health Officer; George L. Askew, MD, FAAP, DCAO for Health & Human Services and Ronald Gill, Director, Emergency Management. Rhonda Weaver, County Attorney spoke to the details of the legislation. Dr. Carter, Dr. Askew and Mr. Gill, provided an update on the status of the virus in the County. The Panelists responded to questions from Council Members regarding coordination with neighboring Counties, pop-up testing sites, cost of testing, insurance, emergency alerts, enforcement of mask wearing, expiration date of this resolution, Laurel Hospital, contact tracing data, testing for children, proper way to wear a mask, testing as it relates to the holidays, personal protection equipment in senior living facilities and rehabilitation facilities, private parties, nightclubs in private residences, restaurant operation in residences, noise complaints and fines.
