The Honorable Steny H. Hoyer House Majority Leader

Majority Leader Steny H. Hoyer was accompanied by 32. Jim Notter, Chief of Staff (MD05 Office) and Terrance Taylor, District Director. The briefing convened at 11:30 a.m. The Majority Leader provided an update on the insurrection, relief legislation, budget, budget reconciliation, vaccinations, voting, redistricting, census, campaign funding, infrastructure funding, systemic racism, climate, Affordable Care Act, FBI relocation to Prince George's County and the transit system. Majority Leader Hoyer responded to questions posed by Council Members regarding, MAGLEV, District of Columbia Statehood, censureship, exclusion from Committies, minimum wage, reconciliation requirements, Federal earmarks, flooding in south County, Joint Base Andrews, mass transit over the Woodrow Wilson Bridge, mortgage deferment, additional Federal agencies moving to the County, security needs, tax reform, student loans, income disparity and the Bureau of Printing and Engraving. This 20-year financing will provide up to \$20 million plus costs of issuance and underwriting to substantially renovate the building located at 8118 Good Luck Road, Lanham, Maryland 20706 thereby converting it into an equipped 16-bed inpatient and ambulatory behavioral health services facility. All operations and maintenance costs will be the responsibility of Doctors' Hospital, Inc., owner of the facility. Fiscal impact is negative. The County is responsible for COP debt service via annual appropriation. Chair Hawkins announced that this Resolution requires a public hearing.
